GIFT TO TOWN. Patricia Lausier, 147 Washington Street and Bill Conly, 19 Hewitt Street, appeared before the Board to present a gift to the Town on behalf of Ross and Rita Terrian, owners of an antique shop in Marblehead for many years. The gift, in the amount of \$692,711.00, is made on the condition that all income therefrom and the principle be used for the creation of a repository for the Town of Marblehead historical documents and records. This management of the facility is to be under the control of the Town of Marblehead Historical Commission. The facility created shall be in the name of Ross and Rita Terrian. Motion made and seconded to accept as a gift to the Town \$692,711.00 from Ross and Rita Terrian for the creation of a repository for historical documents and records in accordance with the terms and conditions presented. The chair, placed in any location to remain perpetually empty, is intended to help people remember that even though our soldiers are not here there is still a space for them. DEPARTMENT OF PUBLIC WORKS. Appointments. Director. Assistant Director. David Donahue, Public Works Director, appeared before the Board. MARBLEHEAD HISTORICAL COMMISSION. Community Wide Historic Preservation Master Plan. Deed to Town. Chris Johnston, 5 Crestwood Road, appeared before the Board on behalf of the Marblehead Historical Commission. Mr. Johnston notified the Board that the Commission has completed the Final Report on the

Marblehead Community Wide Historic Preservation Survey Master Plan. The results of this report identifies 14 neighborhoods and documents the history and development of those neighborhoods since the founding of the Town; identifies threats to the Town's historic resources; provides survey recommendations for the entire Town, by neighborhood; provides a phased and prioritized survey master plan for the Town; provides cost estimates for each phase and a sample scope of work for future historic preservation surveys. The final report is available on the Historic Commission web site at www.Marblehead.org with a hard copy available with the Town Planner and the Historical Commission office at Abbot Hall. **TOWN DEED.** Mr. Johnston notified the Board that the Deed to the Town has slipped in its frame and has possible deterioration. Upon having the Deed inspected the Historical Commission recommends that a digital copy of the Deed be made as well as flattening the original and remounting it, storing the original in an environmentally controlled archival facility. Motion made and seconded to approve the recommendation from the Marblehead Historical Commission to restore the Town Deed and to have a digital copy of the Deed made, to be paid from the Spirit of 76 Fund, cost not to exceed \$4,000.00. COUNCIL ON AGING. Interviews. Appointment. Mr. Christensen disclosed, in accordance with Mass General Laws, that he does not have a conflict with participating in the selection process and that he can be objective to the interviews and the process.
