**MINUTES.** Motion made and seconded to approve the minutes from March 19, 2012. All in favor.

**FIREWORKS COMMITTEE. Annual 4<sup>th</sup> of July Fireworks Display.** Alexander Falk, 452 Atlantic Avenue, appeared before the Selectmen to update them on the annual Fireworks Display. Mr. Falk reported that there has been a very good response this year from the community and he is confident that they will raise the necessary funds. The Annual 4<sup>th</sup> of July Fireworks Display will be held at the mouth of the Harbor on Wednesday, July 4, 2012, rain date Thursday, July 5, 2012. Harbor Illumination starts at 8:45 p.m., Fireworks display at 9:00 p.m. Residents and business owners are encouraged to keep sending their tax deductible donations to the Selectmen's office and put "Fireworks" on the memo line. Mr. Falk thanked all those who have made donations.

**FIRE DEPARTMENT. Recognition.** Chief Jason Gilliland appeared before the Selectmen with Gary Orellana of Lynn, to present Orellana with a award from the State recognizing his quick response to a fire that was set outside the Eastern Bank in January. Orellana, employed at Crosby's Marketplace, quickly got a fire extinguisher and put out the flames, preventing the fire from spreading to the rest of the building. Chief Gilliland thanked Mr. Orellana for his efforts.

**ANNUAL FIREFIGHTERS COOKOFF.** Chief Gilliland announced the Annual Firefighters Cook Off will take place Saturday, March 31, 2012, 6:00 p.m. at the Danversport Yacht Club. This is a fundraiser for the Muscular Dystrophy Association.

**ALL ALCOHOLIC BEVERAGE LICENSE. Pellino's Restaurant.** Frank Pellino, 4 Mustang Circle, Danvers, appeared before the Board to discuss the recent closing of his restaurant on Washington Street. He has opened a second restaurant in the North End and lost some of his employees in Marblehead. Mr. Pellino stated he has received an offer on the restaurant and if that did not go through he plans to reopen Pellino's sometime in May. Mr.

**VETERANS AGENT. Re-appointment.** Motion made and seconded to re-appoint David C. Rodgers Veteran's Agent for the Town with a term to expire in May 2013. All in favor.

**ARBOR DAY. Proclamation.** Motion made and seconded to approve the request from Douglas Gordon, Tree Warden, to proclaim Saturday, April 28, 2012 as Arbor Day for the Town of Marblehead. The Chair read the proclamation into the minutes. All in favor.

**PERMISSION. National Prayer Day.** Motion made and seconded to approve the request from Donald Orne, Chairman, Marblehead Peace Committee, to ring Abbot Hall's bell at noon on May 3, 2012 for five minutes immediately following the noon ringing in honor of the sixteenth National Prayer Day and to meet in the Selectmen's Meeting room for 10 minutes to pray and meditate as one unified group for all of our son's and daughter's return from all areas of danger. The public is invited to attend. All in favor.

**CONTRACT. Stramski Fence.** Motion made and seconded to award a contract for the Stramski fence project to Budget Fence Co. Inc. of Revere, MA in the amount of twelve thousand nine hundred and forty and 00/100 (\$12,940.00) and authorize the chair to sign the contract on behalf of the Board. All in favor.

**CONTRACT. Pickett House Painting.** Motion made and seconded to award a contract for the exterior painting of the town owned Pickett House to Tom's Painting Contracting Co. of Marblehead, MA in the amount of eight thousand five hundred and 00/100 (\$8,500.00) and authorize the chair to sign the contract on behalf of the Board. **MARBLEHEAD COMMUNITY ACCESS AND MEDIA. Proposed Legislation.** Motion made and seconded to send a letter to Senator McGee and Representative Ehrlich stating the Boards opposition to proposed legislation, House Bill HB3558 or 2011-2012 *An Act Promoting Consumer Choice and Competition for Cable Service* and to authorize the Chair to sign on behalf of the Board. The bill would substantially reduce the cable licensing timetable for municipal licensing authorities in addition to proposing considerable cuts to Verizon's commitment to support public, educational, and governmental access in Marblehead. All in favor.

**FAIR HOUSING COMMITTEE. Applicant.** A letter of interest was received from Jim Vipperman, 149 Village Street, as it relates to serving on the Fair Housing Committee. The Board will interview Mr. Vipperman at their April 11, 2012 meeting.

**MBTA Advisory Board. Meeting.** The MBTA Advisory Board Meeting of Thursday, March 29, 2012 has been rescheduled to May 1, 2012, 9:30 a.m. at the State Transportation Building, 10 Park Plaza, Conference Room #1, 2<sup>nd</sup> Floor.

**ARTICLE 35. Old Town House.** The Board was notified that the Old Marblehead Improvement Association (OMIA) has hired the consultant to make a power point presentation at

the Marblehead Museum's Annual Meeting regarding the Old Town House at Abbot Hall on Thursday, April 5, 2012. The Annual Meeting starts at 6:30 p.m. with the presentation at 7:00 p.m. This event is free and open to the public. The Marblehead Museum and Historical Society voted unanimously to support Article 35, Old Town House, at 2012 Annual Town Meeting.

**WATER AND SEWER COMMISSION. Article 14, Surface Drainage Construction.**

Wilbur Bassett, Water & Sewer Commissioner, appeared before the Board to express his concerns with the recent Finance Committee meeting as it relates to Article 14, Surface Drainage Construction. Pam Evans, 30 Evans Road, Steven Pike, 36 Evans Road and Marguerita Reczycki, 31 Evans Road, addressed the Board with their concerns and seeking the Town's support for Article 14, Surface Drainage Construction. The Board stated they are co-sponsors of Article 14 and support it 100%.
