The walk/run will start at 9:00 a.m. at Devereux Beach, continue down Ocean Avenue, past lighthouse onto Harbor and back to the Beach, finishing by 2:00 p.m. The event raises money for BARKA Foundation, a United Nations affiliated, non-governmental organization, which focuses on clean water initiatives in one of the poorest countries in the world; Burkina Faso, South Africa.
