MARBLEHEAD COMMUNITY ACCESS AND MEDIA. Proposed Legislation. A letter was received from Robert Peck, President, as it relates to seeking support from the Selectmen to send a letter opposing proposed legislation, Senate Bill 1687 An Act Promoting Consumer Choice and Competition for Cable Service. Mr. Peck notes that bill significantly limits the amount of time that a cable company, seeking a license to operate, is required to negotiate with the local municipality for the use of the public rights of ways. The shortened time period of 90 days proposed in the bill does not allow adequate time for local officials to determine the community needs. Motion made and seconded to send a letter from the Board of Selectman to Senator Thomas McGee in opposition to the proposed legislation. All in favor.
