COUNCIL ON AGING. Spring Four-Star Raffle. Patricia Charbonnier, 35 Overlook Road and Ron Olson, 154 Lafayette Street, appeared before the Selectmen as it relates to the Spring Four-Star Raffle to benefit the Friends of Marblehead Council on Aging. Members of the Board drew four names for the prizes.

EAGLE SCOUT CANDIDATE. Eamon Dawes, 2 Mohawk Road, and Chief Jason Gilliland appeared before the Board to present Eamon's upcoming Eagle Scout Service Project. Eamon, with a group of volunteers, will be marking 115 fire hydrants over Memorial Day Weekend in the vicinity of the Fire Station on Pleasant Street and continuing towards the Marblehead Light Department. Marking the light poles identifying the distance to the nearest fire hydrants allows for quick access and clearing of the hydrants during winter snow storms.
