**MINUTES.** Motion made and seconded to approve the minutes from June 2, 2010. All in favor.

**PERMISSION. Breast Friends Walk.** Motion made and seconded to approve the request from Carol Smith, on behalf of Adam Smith, to hold the 5<sup>th</sup> Annual Breast Friends Walk on October 3, 2010 at 9:00am subject to approval from the Marblehead Police, Fire, Recreation and Parks Department and receipt of the required Certificate of Insurance. The walk will begin and end at Devereux Beach and loop Marblehead Neck. All in favor.

**PERMISSION.
