MINUTES. Motion made and seconded to approve the minutes from May 11, 2016. All in favor.

HISTORICAL COMMISSION. Presentation of Historical Documents. Members of the Historical Commission appeared before the Board. Four important historical documents from the Revolutionary period have been displayed in the Board of Selectmen's Room, these include:

- George Washington's letter to the inhabitants of Marblehead in 1789
- Elbridge Gerry's letter to the Selectmen accepting appointment to the Massachusetts Provincial Congress in 1774
- Paul Revere's letter to Jonathan Glover and the Selectmen attempting to procure surplus cannon from the Town, written in 1787
- Resolution of the Massachusetts General Court Senate and House relative to a Marblehead petition, signed by John Hancock as Governor and Samuel Adams as Senate president, written in 1784

The Historical Commission has recently completed the restoration, digitizing and framing of replica documents which are now hanging on display in the Selectmen's Room. Chair Belf-Becker acknowledge and thanked the many individuals involved with this process: Robin Michaud, Town Clerk; Marblehead Historical Commission, especially Chris Johnston Chairman; Wayne Butler and all Historic Commission volunteer archivists; Don Doliber, Town Historian and Chris Butler and Dan Williams, Building Department.

POLICE DEPARTMENT. Plan Summary. Chief Robert O. Picariello appeared before the Board to present the Departments Strategic Plan “Continuing Forward 2021” as expanded/revised by an Advisory Committee established by the Board. The Advisory Committee recommendations included in the Plan’s design are intended to increase the transparency of the Department’s actions. The Action Plan is intended to broaden public knowledge about police operations. The timeline for this strategic plan/action plan is five years and it is recognized that some action items will be impacted by funding. USS MANLEY (DD940) ASSOCIATION. Naming of Navy Ship. A letter was received from Harold Kane, President, USS Manley (DD-940) Association, as it relates to a petition to the Secretary of the Navy to name a warship after John Manly, born in 1733 in England, settled in Marblehead, became a merchant seaman and a Ship's Master and during the Revolutionary War served under General George Washington and the Continental Army first as the commander of the schooner *Lee*, later as the Commodore of Washington's "Schooner Squadron" and later upon formation of the Continental Navy was commissioned a Captain becoming its second most senior ranking officer being known as the "Commodore of George Washington's Navy". He was captured and imprisoned, returned to service as a Privateer and finally to assume the command of the Navy's frigate *Hague*. Motion made and seconded to support a resolution to name a new Navy Ship after John Manley. All in favor.

ROBINSON FARM TOURS. Letter of Appreciation. Motion made and seconded to send a letter of congratulations to the fourth grade students of the Village School on the recent tours the students gave to the public at Robinson Farms. All in favor.

EXECUTIVE SESSION.
