MINUTES. Motion made and seconded to approve the minutes from May 14, 2008. All in favor.

VOTE. Contract. Motion made and seconded to award a contract for the exterior painting of a portion the Tower Way building to Osgood Painting and Contracting Services LLC of Marblehead in the amount of thirteen thousand one hundred Dollars (\$13,100.00) and authorize the chairman to sign on behalf of the Board. All in favor.

PERMISSION. Use of Fort Sewall. Motion made and seconded to approve the request from the Marblehead Festival of Arts to use Fort Sewall on Sunday, June 29, 2008 for the purpose of conducting their annual Champagne reception and culinary food tasting fundraiser subject to the usual rules, regulations and fees, approval from the Marblehead Police, receipt of the required Certificate of Insurance and that the Fort remain open to the public at all times. All in favor.

PERMISSION. Pod Placement. Motion made and seconded to approve the request from Dawn Carreiro, New England Portable Storage, LLC to place a POD container at 10 Edgewood Road subject to delivery of the POD be coordinated with the Marblehead Police to insure proper placement. Approval is valid until June 11, 2008 at which time the Board will revisit the length of time requested for the placement of the POD. All in favor.

DIVISION OF MARINE FISHERIES. Red Tide. Notice was read as follows: "under Massachusetts General Laws, Chapter 130, Section 74A and 75 the following areas are CLOSED TO THE TAKING OF BEVALVE SHELLFISH AND CARNIVEROUS SNAILS, WITH THE EXCEPTION OF THE ADDUCTOR OF THE SEA SCALLOP, effective immediately: Salisbury, Newbury, Newburyport, Rowley, Ipswich, Essex, Gloucester, Rockport, Manchester, Beverly, Marblehead, Salem, Swampscott, Lynn and Nahant. Digging, harvesting or collecting and/or attempting to dig, harvest or collect shellfish and possession of shellfish, including carnivorous snails is prohibited."
