MINUTES. Motion made and seconded to approve the minutes from August 13, 2008. 4 in favor, 1 vote present. Motion made and seconded to approve the minutes from August 25, 2008. 4 in favor, 1 vote present. All in favor.

MARBLEHEAD HISTORICAL COMMISSION. Wayne Butler, Marblehead Historical Commission, appeared before the Board. Motion made and seconded to approve the request from Mr. Butler to award "Marblehead" pins to the volunteers at the Commission office, gift shop, maritime room and to all others that may assist the work of the Marblehead Historical Commission in the collection and preservation of Marblehead's history. All in favor. Motion made and seconded to sell similar "Marblehead" pins with the Town Seal, at the gift shop subject to approval from Town Counsel. All in favor. Motion made and seconded to send a letter with Mr. David Downs to Grasse, France, sister city to Marblehead with greetings from the Board of Selectmen as well as a poster of the "Spirit of 76" and a collection of locally written and published books from the gift shop. All in favor. Regarding other Commission news; Mr. Butler informed the board that a bronze plaque with the original words "Marblehead Forever" will be dedicated to the late Paul Lausier, former Chairman of the Historical Commission, and Marcia Selman, author of the words, on Veteran's Day and then hung in the Auditorium upstairs at Abbot Hall along with a display case of items from Mr. Lausier's collection. Lastly, the platform to display the two bells from the USS Marblehead is nearly finished and will soon be in the rotuna.

PERMISSION. Marblehead/Swampscott YMCA. Proclamation. Shalane Flanagan Day. Paul Gorman, Executive Director and Susan Guertin, Aquatics Director of Marblehead/Swampscott YMCA appeared before the Board as it relates to the request from the YMCA to proclaim Saturday, September 27, 2008 as "Shalane Flanagan Day" in honor of her success in winning the bronze medal in the 10,000 meter track race at the 2008 Beijing Olympics. Motion made and seconded to proclaim Saturday, September

27, 2008 "Shalane Flanagan Day". All in favor. Motion made and seconded to approve the following motorcade route for Saturday, September 27, 2008 beginning at 1:00pm: Begin at the YMCA on Pleasant Street Proceed up Pleasant to Washington Street Right on Washington Street to Atlantic Avenue. Left on Atlantic Avenue to Smith Street. Right on Smith Street to Pleasant Street. Left on Pleasant Street to Humphrey Street.

Bear Left on Humphrey Street to Tedesco Street. Bear right on Tedesco Street to Leggs Hill Road

Right on Leggs Hill Road to new YMCA.

The motorcade will end at the new YMCA where there will be a ceremony that includes presentations from the Town of Marblehead, the Marblehead School Department, the State of Massachusetts and the Marblehead Swampscott YMCA. All in favor.

Motion made and seconded to prepare a Proclamation to be delivered to Shalane Flanagan on behalf of the Town of Marblehead on Saturday, September 27, 2008 and to have her achievement at the 2008 Beijing Olympics notated in the 2008 Annual Town Report. All in favor.

CULTURAL COUNCIL. Interviews. Appointments. Gloria Coolidge and Nora Falk appeared before the Board to be interviewed for a position on the Cultural Council. Motion made and seconded to appoint Gloria Coolidge to the Cultural Council with a term to expire in May 2011. All in favor. RECREATION, PARKS AND FORESTRY. Gifts to the Town. Motion made and seconded to approve the request from Derek Norcross, Recreation, Parks and Forestry Commission to accept as a gift to the Town the new street hockey rink at Reynolds Playground and the new backboards, rims and poles at the Seaside Park basketball court. All in favor. Motion made and seconded to create a donation fund for maintenance of the new street hockey rink at Reynolds Playground. Motion made and seconded to send a letter of thanks to the Marblehead Youth Hockey League and Youth Basketball Association for donating these gifts to the Town. All in favor.

VOTE. Motion made and seconded, following approval of Town Counsel, to execute a contract between the Town of Marblehead and Hess Corporation for the purchase of natural gas and to have the Chairman sign on behalf of the Board. All in favor.

Roundhouse Road. Motion made and seconded to temporarily make Roundhouse Road, railroad –right-of-way, as well as the One-Way, upper portion on Anderson Street, a **NO PARKING, TOW ZONE** area for the purpose of the annual clean-up and repairs on the following dates:

No parking will be allowed at the wharf between 9:30am – 3:00pm. All in favor.

MBTA. Preliminary 2008 Service Plan. Motion made and seconded to take no action on the request by Rick Patoski, MBTA Advisory Committee, to seek a reduction in bus service to Marblehead. All in Favor. Motion made and seconded to send a letter to Rick Patoski stating that the Board does not agree with his position and that they hope he would support the Boards position to maintain the current level of bus service to the Town. All in favor.

OLD AND HISTORIC DISTRICTS COMMISSION. Applicant. A letter of interest was read from Cheryl Boots as it relates to serving on the Old and Historic Districts Commission.
