MINUTES. Motion made and seconded to approve the minutes of December 19, 2006. All in favor.

MARBLEHEAD HISTORICAL COMMISSION. Gift. Wayne Butler and William E. Conly, commission members were present to announce that Dr. Ray F. Cole, Jr., (also a commission member and present) has given the following gifts to the Town:

\$250,000 to the Commission to be used by the Commission to maintain the Nautical Room at Abbot Hall and the items presently on display in the Nautical Room.

The room to be named "The Marblehead Maritime Museum" sponsored by Dr. Raymond F. Cole, Jr.

Motion made and seconded to accept the gifts and to send a letter of appreciation to Dr. Cole. All in favor.

PERMISSION. Spirit of '76. Letter from Dr. Cole requesting permission to reproduce a photograph of him standing before the Spirit of '76 painting in a book he has written entitled "Fighting Ships". Motion made and seconded to grant permission. All in favor.

Request from Karin A. Anderson on behalf of the Marblehead Little Theatre, 12 School Street for a liquor license to serve alcohol on February 10 and 14 at the theatre between 7:00 p.m. and 11:30 p.m.

Motion made and seconded to approve subject to payment of the requisite fee and insurance. All in favor.

Motion made and seconded to approve the request received from James R. Carney, Chief Police Department to continue the following:

Motion made and seconded to approve the request received from Patricia C. Roberts, Director, Council on Aging to continue a revolving fund in the amount of \$200,000. All in favor.

LICENSING. Common Victualer. Entertainment. Devereux Beach Concession.
Paul Petersiel, President of Devereux Beach Corp., d/b/a Lime Rickey's, 105 Ocean Avenue was present in connection with the following license applications: Common Victualer, Entertainment (non-Sunday) and Entertainment (Sunday).

Motion made and seconded to grant the common victualer license to operate the concession seven days a week during the hours of 7:00 am to 11:00 pm., subject to all taxes and fees to the Town being paid and receipt of all applicable departmental approvals. All in favor.

Motion made and seconded to support Mr. Petersiel's improvement of the existing public address system and addition of a television at the concession. All in favor.

Town Administrator Anthony M. Sasso advised Mr. Petersiel that prior to making the improvements to the public address system and adding the television he must get the endorsement of the Recreation Parks and Forestry Commission.

Motion made and seconded to table Mr. Petersiel's request for an entertainment license for live and recorded music pending review by the Recreation, Parks and Forestry Commission. All in favor.

Mr. Christensen left the meeting at 7:45 p.m. due to a potential conflict of interest relating to the Town's search for a new police chief.

Motion made and seconded to appoint Mr. Shribman, as acting chairman during discussion relating to the police chief search. All in favor.

POLICE DEPARTMENT. Police Chief Search. Rebecca Curran, Chief Procurement Officer was present to announce that the town has received two bids in response to the request for quotations issued by the town to procure consulting services to design and conduct a sole assessment center for the position of police chief. Ms. Curran [went through the evaluation criteria recommended that the board rank Badge Quest of West Yarmouth Massachusetts as the most advantageous respondent.](#) Motion made and seconded to select Badgequest as the company most advantageous to the town and as the most responsive and responsible respondent [and award the contract for consulting services to design and conduct a sole assessment center for the hiring of a new police chief in the amount of six thousand nine hundred dollars \(\\$6,900\) and authorize the acting chairman to sign on behalf of the board.](#) All in favor.

ANNUAL TOWN MEETING 2007. Open Space Committee Articles. Naugus Avenue. Norman Street. Robinson Farm. Walt Haug, Diane St. Laurent, Bradford N. Freeman and Richard Harrison, Open Space Committee members were present to request that the Selectmen sponsor the following article for inclusion at Annual Town Meeting:

To see if the Town will vote to acquire for conservation and recreation purposes a fee simple interest in certain parcel(s) of land totaling approximately three acres commonly known as the WESX property located on Naugus Avenue;

Motion made and seconded to sponsor the article subject to review by town counsel. All in favor.

A request was also made for the Selectmen's sponsorship of the following article:

To see if the Town will vote to purchase or otherwise acquire a portion of certain parcel of property located on Norman Street.

Motion made and seconded to sponsor the article subject to review by town counsel. All in favor.

A request was made for the Selectmen to jointly sponsor an article with the Conservation Commission that would transfer care of the Robinson Farm property (currently under the control of the Board of Selectmen) to the Commission for open space purposes.

Motion made and seconded to sponsor the article subject to review by town counsel. All in favor.

PROCLAMATION. Marblehead Reads. Grant. Bonnie Strong, Director of the Abbot Public Library was present to announce that the library has received a grant in the sum of

\$7,500. for a project dubbed “Marblehead Reads” in which everyone in town is encouraged to read the same book (Nat Philbrick’s - In the Heart of the Sea). To celebrate this Ms. Strong requested that March be declared “Marblehead Reads” month. Motion made and seconded to make such declaration. All in favor.

Motion made and seconded to approve subject to the rules and regulations, receipt of required insurance and payment of applicable fees. All in favor.

At the advice of counsel Mr. Nye left the meeting at 8:30 p.m. due to a potential conflict of interest.

PROPOSED TREE REMOVAL. Kimball and Nahant Streets. Tree Warden R. T. Hamond was present in connection with the removal of trees at Kimball Street (adjacent to 2 Nahant Street) proposed by Paul and Nancy McCarthy of 2 Nahant Street and a letter of disapproval and objection to the removal of trees received from William J. Lundregan of 11 Faye Circle. Mr. Hamond made the following statement:

“In accordance with Massachusetts General Law, Chapter 87 Section 3 a hearing was held on January 2, 2007, before Thomas Hamond, Tree Warden, Town of Marblehead, with respect to the proposed removal of five (5) shade trees on Kimball Street by Paul and Nancy McCarthy of 2 Nahant Street (corner of Kimball Street), Marblehead, Massachusetts.

Since resident William J. Lundregan of 17 Faye Circle, Marblehead, Massachusetts filed an objection dated December 28, 2006 in opposition to the cutting down of the shade trees, the trees may not be cut or removed without the approval of the Board of Selectmen.”

Mr. Hamond asked that the Selectmen approve the removal of trees as proposed by Mr. and Mrs. McCarthy with the condition that three trees be replaced (in a location determined by Mr. Hamond). Motion made and seconded to approve. All in favor.

Mr. Nye returned to the meeting at 9:02 p.m.
