**MINUTES.** Motion made and seconded to approve the Minutes of June 13, 2007. All in favor.

**OLD AND HISTORICS DISTRICT COMMISSION**. Motion made and seconded to approve the appointment of Susan Bragdon as an alternate to the Old and Historic District Commission with a term to expire in May 2008. All in favor. Motion made and seconded to appoint Karl Renney as a regular member of the Old and Historic District Commission with a term to expire in May 2008. All in favor. Motion made and seconded to appoint F. Reed Cutting, Jr. as a regular member of the Old and Historic District Commission with a term to expire in May 2008. All in favor.

**LICENSE. One-Day All Alcoholic.** Motion made and seconded to approve the request of Gregory Triplett of the Marblehead Festival of Arts to have a one-day all alcoholic beverage license for Sunday, June 24, 2007 from 5 to 7 p.m. at Fort Sewall. **PERMISSION.** Motion made and seconded to approve the request of Jeffrey Wargo of the Eastern Yacht Club to block Ballast Lane beginning in the front of 21 Ballast Lane past 27 Ballast Lane and around the portion of Ballast Lane that is adjacent to the Eastern property from 1 p.m. to 10 p.m. on Saturday, August 4, 2007 subject to the required liability insurance if the event should use any Town property. All in favor. It is understood a detail police officer(s) will be hired for this event.

**PERMISSION.** Block Party. Motion made and seconded to approve the request of Tim and Peg Slattery to block Taft Street for a block party on Wednesday, July 4, 2007 from 2 p.m. to 8 p.m. subject to Police and Fire Departments approvals. All in favor.

**TRAFFIC & SAFETY.** Motion made and seconded to refer to the Traffic & Safety Committee the request of Pamela Flynn of Five Haley Road to have parking on one side of the street. All in favor.

**PERMISSION.** Andrew Harrison, Location Manager of Lock and Key Productions appeared before the Board. A discussion followed as it relates to the possible construction project his company is proposing in Marblehead.
