

**BOARD OF SELECTMEN
MINUTES**

May 16, 2007

Board met in Regular Session at 7:30 p.m. in its meeting room at Abbot Hall.

Town Clerk, Thomas McNulty, appeared to swear in the newly elected Board. This is the 360th Board of Selectmen for the Town of Marblehead.

Motion made and seconded to nominate Harry C. Christensen, Jr. as Chairman for the coming year. All in favor.

The Board welcomed the return to the Board of Selectmen of William L. Woodfin, II. Mr. Woodfin replaced Jeffrey N. Shribman who chose not to run for re-election. Motion made and seconded to thank Jeff Shribman for his years of service to the Town and to send him a letter stating so. All in favor.

Chairman Christensen noted the passing of former Cemetery Superintendent and Cemetery Commissioner, Benjamin Arthur Woodfin. Motion made and seconded to send his family a letter of condolence.

MINUTES. Motion made and seconded to approve the Minutes of May 2, 2007. Four selectmen voted in favor with Mr. Woodfin voting present.

Motion made and seconded to approve the Minutes of May 7, 2007. Four selectmen voted in favor with Mr. Woodfin voting present.

PERMISSION. Linda A. Meiggs, Property Manager of Marblehead Atlantic LLC appeared before the Board seeking permission to occupy Town property by virtue of improvements to be made at 40-48 Atlantic Avenue and 50-54 Atlantic Avenue. The proposed improvements will overhang Town property. They include new cornices, soffits, exterior lighting and awnings as well as new storefronts being installed. The building will be painted white. LICENSE. All Alcoholic Beverage License. The Hurricane Restaurant, Inc. A public hearing was held as it relates to the application of the Hurricane Restaurant, Inc. to extend the seating to the outdoors by adding eight seats in the area immediately abutting and running parallel with the premises. Seating is to be entirely within the premises leased by Licensee. Hours of operation will be 11:00 a.m. to midnight Mondays through Fridays and 8:00 a.m. to midnight on Saturdays and Sundays. Peter McMahon, Manager appeared before the Board. Motion made and seconded for reconsideration of the April 25, 2007 vote as it relates to adding fifteen seats in the same area. The Board voted as follows: Mr. Nye, in favor; Mr. Woodfin, in favor; Mrs. Jacobi, in favor; Mrs. Belf-Becker, in favor, and Mr. Christensen, in favor. Attorney Christ Drucas was present, representing his client Stephen Lockwood, an abutter to the premises. He requested a limit be put on the time alcohol could be served at these additional seats. Motion made and seconded to approve this application. The Board voted as follows: Mr. Nye, in favor, Mr. Woodfin, not in favor; Mrs. Jacobi, in favor; Mrs. Belf-Becker, in favor; and Mr. Christensen, not in favor.
