**LIME RICKEY'S. Devereux Beach Concession. Alterations to Property.** Paul Petersiel, President of Devereux Beach Corp., d/b/a Lime Rickey's, the new tenant at the concession was present to discuss his plans to make some changes, at his sole cost to the leased premises. The changes will be reviewed by the Zoning Board and the Conservation Commission and will be subject to all required permits being obtained. None of the Selectmen expressed opposition the proposed changes.

MASSACHUSETTS WATER RESOURCES AUTHORITY (MWRA). Budget Cut FY07. Letter from Frederick A. Laskey, Executive Director of MWRA that the MWRA will be working closely with its Advisory Board and the Legislature to have the following reversed: Governor Romney's cut that provides debt service assistance to water and sewer agencies across the state. For Marblehead, this could force a rate increase for FY07 and mean an additional \$28,195.

# KSS/LAFAYETTE TIDES. Updates.

Lisa Mead, Esq., Town Counsel was present to give an update on recent developments of the site proposed by 485 Lafayette Street Acquisitions, LLC, the "Developer".

Stephen Smith, principal of the Developer was present with Mike Binette member of the Developer's architectural team and Bob Mulcahy, landscape architect to present two options considered for the development:

One option is to construct 44 condominium units on the site under Chapter 40B of the MA General Laws. 11 of the 44 units will be affordable. A continued public hearing before the Zoning Board of Appeals on the application of the Developer for a comprehensive permit under Chapter 40B is scheduled for Monday, December 18 at 7:30 p.m. The hearing will be held at the Community Center, 2 Humphrey St.

Another option is to construct a thirty unit condominium style development on the site. This option would require an amendment to the town's zoning laws by town meeting action.
