MINUTES. Motion made and seconded to approve the Minutes of September 13, 2006. All in favor.

PROCLAMATION. Dr George L. MacDonald appeared before the Board to recognize William S. (Esso) Haines for all the work he has done with the youth of the Town. Motion made and seconded to declare Saturday, September 30, 2006 as William S. (Esso) Haines Day in Marblehead. All in favor.

PEACE COMMITTEE. Sandra Winter and Devon Hildreth appeared before the Board to discuss the replacement of the Peace Pole. They as well as Don Orne spoke on behalf of replacing the Pole somewhere other than Memorial Park. No action was taken.

PERMISSION. Awning. Valerie White of 12 Spring Street appeared before the Board seeking permission to place an awning overhanging the public way at 237 Washington Street. She is opening a new shop named Bobbles which will sell accessories and costume jewelry. Motion made and seconded to approve this request subject to the usual conditions and receipt of a Certificate of Insurance naming the Town of Marblehead as an additional insured. All in favor.

TRAFFIC AND SAFETY. Pleasant Street/Ocean Ave. Motion made and seconded to approve the request of Lt. Dave Millett of the Marblehead Police Department that the "No Left Turn" sign be removed from the pole at the intersection of Pleasant Street and Ocean Avenues for a 30-day trial period. All in favor.

Bailey Square. Motion made and seconded to approve the request of Lt. Dave Millet of the Marblehead Police Department that the "No Turn on Red" restriction at the intersection of Maple Street, Tedesco Street and Humphrey Street be amended to read "No Turn on Walk." After a brief discussion, motion made and seconded to table. Would like a report from Lt. Millett as it relates on the right on red from Maple to Tedesco and how the turn to Humphrey Street would work. All in favor.

West Shore Drive. Motion made and seconded to approve the request of Lt. Dave Millet of the Marblehead Police Department to remove seven signs reading "No Parking, 7 a.m. to 5 p.m." lining the easterly side of West Shore Drive between Lorraine Terrace and Village Street. All in favor.

WINTER PARKING BAN. Motion made and seconded to have the winter parking ban commence at midnight on Sunday, November 27, 2006. In the case of a snow emergency, all cars will have to get off the street. All in favor.

TRANSFER STATION. Chairman Christensen announced that the transfer station will be closed on Saturday, November 11, 2006 in honor of Veterans' Day.

VETERAN. Motion made and seconded to send a letter of condolence to the mother of Jared Raymond of Swampscott who was killed in Iraq. His funeral is scheduled for tomorrow. All in favor.
