MINUTES. Motion made and seconded to approve the minutes from December 12, 2018. All in favor. Motion made and seconded to approve the minutes from December 19, 2018. All in favor.

PUBLIC HEARING. Carry-In Alcoholic Beverage License. Fresca Pizza and Pasta, 50 Atlantic Avenue. The Chair read a message from Marcos Santana, Manager, Fresca Pizza and Pasta, requesting permission for his wife, Queila Santana, Broughton Drive, Beverly, to represent him before the Board as it relates to his application for a Carry-In Alcoholic Beverage License at 50 Atlantic Avenue. Linda Meggs, Providence, Rhode Island, landlord of 50 Atlantic Avenue, spoke in favor of the applicant. No one spoke in opposition. Motion made and seconded to approve the application from Fresca Pizza and Pasta, 50 Atlantic Avenue, Manager Marcos Santana, for a Carry-in Alcoholic Beverage License (Beer & Wine) subject to approval from Chief Picariello, receipt of the required forms, fees, departmental approvals, CORI review and that such permit shall expire on an approval from the ABCC for any future transfer or application. A TIPS or BAT trained person must be on the premises at all times that Carry-In is allowed. Hours of operation for Carry In are Tuesday through Sunday 11:00 a.m. - 9:00 p.m., Seating Capacity = 16. BELLS. Washington's Birthday. Motion made and seconded that the bells of Abbot Hall and all the churches in Marblehead be rung on Washington's Birthday, Friday, February 22, 2019 at the usual holiday hours from 7:30 a.m. to 8:00 a.m.; 12 noon to 12:30 p.m.; 6:00 p.m. to 6:30 p.m. as has been the custom in the past. No permanent markings shall be made on the streets and any temporary markings shall be removed at the conclusion of the event. The event will start and finish at Devereux Beach. All in favor.

Motion made and seconded to approve the request from B&S Fitness to hold the 7th Annual Black Cat 10/20 Miler on Saturday, March 9, 2019 subject to approval of the Marblehead Police and Recreation and Parks Department, Police Details and receipt of the required Certificate of Insurance.
