**PERMISSION. Black Cat 10/20 Miler. Revised date.** Motion made and seconded to approve the request from Brandi Dion, B&S Fitness Companies, to amend the previously approved date to run the Black Cat 10/20 Miler from April 4, 2020 to August 8, 2020 subject to approval from the Police Chief, Recreation and Parks, and the usual rules, regulations, fees and receipt of the required Certificate of Insurance.
