January 21, 2015

EXECUTIVE SESSION. Motion made and seconded to go into Executive Session to discuss strategy with respect to litigation, namely <u>Green Street Realty Trust v. Town of Marblehead</u>, Essex Superior Court Docket Nos. ESCV2013-02029 and ESCV2013-02030, where an open meeting may have a detrimental effect on the litigating position of the Town. GIFT TO TOWN. **Corinthian Yacht Club**. Ken Adam, Past Commodore, 7 Buena Vista Road, and Bill Conly, Past Commodore, 19 Hewitt Street, appeared before the Board on behalf of the Corinthian Yacht Club to donate a painting of Pedrick's Wharf in Marblehead, a/k/a Tucker's Wharf, where the Marblehead Harbormaster's Office is today. In 2003 the National Parks Service disassembled the 1770 building and relocated it to Derby Wharf in the Salem Maritime National Historical site. Motion made and seconded to accept the painting as a gift to the Town and to send a letter of thanks to the Corinthian Yacht Club. All in favor.

LICENSING. All Alcoholic Beverage. Yannalfo's. 261 Washington Street. Brett Yannalfo, 523 Lowell Street, Andover, and Frank Pellino, Mustang Circle, Danvers, appeared before the Board as it relates to the All Alcoholic Beverage License at 261 Washington Street. Mr. Yannalfo told the Board that the restaurant is currently closed and he is actively seeking a buyer to transfer the license to and requested time to pursue this. Mr. Pellino, property owner, expressed his commitment to working with Mr. Yannalfo to find a buyer. Motion made and seconded that Mr. Yannalfo report back to

the Board in 90 days and to follow up with the Town Administrator in 45 days with a status update. All in favor.

TOWER SCHOOL. Colgate Road. Robert McCann, Counsel, and Dean Sidell, Tower School Business Manager, appeared before the Board to present a design to address improving circulation at the school and seeking direction from the Town as they proceed. The Chair advised Attorney McCann and Mr. Sidell to continue meeting with the Town Administrator, Town Planner and appropriate Boards and to come back to them at a future date.

HISTORICAL COMMISSION. Grant Application. Chris Johnston, 5 Crestwood Road, Chairman Marblehead Historical Commission and Pat Franklin, 6 Merrill Road, appeared before the Board as it relates to seeking a grant to conduct a Marblehead Coastal Zone Historic Properties Inventory. The grant is a 50% matching grant, with the Massachusetts Historical Commission reimbursing 50% of the project using funds from the National Park Service. The Town of Marblehead Historical Commission will fund its share of the grant using income from the "Reynolds Funds". There will be no cost to the taxpayers of Marblehead. Motion made and seconded to approve the request, as presented, from the Marblehead Historical Commission to submit a FY 2015 Survey and Planning Grant application to the Massachusetts Historical Commission and to authorize the Chair to sign on behalf of the Board.
