POLICE CHIEF. Interviews. Appointment. The Chair read a statement from Shumeane Bendford, one of 3 finalists for Police Chief, withdrawing his name from consideration, choosing to remain in his current role. Chief Benford thanked the Town for a professional and comprehensive process and for the opportunity to be a finalist. The Chair noted that this is the end of a lengthy process led by the Screening Committee including extensive public engagement. Dennis King and Scott Richards were interviewed separately before the Board. After completion of the interviews motion made and seconded to place both names into nomination. Motion that the Marblehead Board of Selectmen appoint Dennis King as the Marblehead Chief of Police subject to completion and approval of a background check, successful completion of a physical, completing all pre-employment requirements and agreement to terms of a contract.
