ANNUAL TREE BURNING. Riverhead. The Fire Chief appeared before the Board to announce that the annual tree burning will take place on January 6, 2022 at 6:00 p.m. at Riverhead Beach. Residents can bring their trees to Riverhead Beach to be included in the tree burning and DPW will be picking up trees curbside as well and drop them at Riverhead.

SUSTAINABLE MARBLEHEAD. Louise Yarmouth, Executive Director, Sustainable Marblehead, gave a brief introduction to the Board on the 2 matters before them. First, Sustainable Marblehead is asking the Town to allocate a portion of ARPA (American Rescue Plan Act) funds to expand the Tree Department and to request that the town allocate the necessary funds to hire a Sustainability Director for the Town in 2022. Pal Bickford, Town Trees and Urban Forestry team, made a further presenation to the Board summarizing the goals for Urban Forestry reiterating the request to the Board to allocate ARPA funds to the Tree Department. Mrs. Noonan asked that the Board motion to direct the APRA working group to consider allocating funds to the Tree Department for the iprove of outdoor spaces as consistent with the Board of Selectmen's prioritizing criteria first priorotu identified as expenses for on going Covid-19 public health and saftery. Moved by Mrs. Noonan, seconded by Mrs. Singer. Mr. Nye sought clarification on the vote. The Board voted as follows: Mrs. Noonan, in favor; Mrs. Singer, in favor; Mr. Nye, opposed; Mrs. Belf-Becker, opposed. The Chair stated that the ARPA working

group is charged with making these decisions and the voted does not mean the Board is against the request but would like the decisions to come from the ARPA group.

Lynn Bryant, Sustainable Marblehead Board Member, addressed the Board asking them to consider allocating the necessary funds to hire a Sustainability Director for the Town for 2022. Ms. Bryant detailed how a Sustainability Director could assist the Town; plan for and achieve net zero carbon emissions by 2040, apply for grants, educate residents, establish benchmarks and metrics for measuring sustainability performace and document progress, act as resource to regulatory boards, help implement Green Marblehead's energy efficiency goals and more. Ms. Bryant asked that the Town adopt a resolution stating the Town shall work with Sustainable Marblehead to develop this position of Sustainability Director and that this recommendation be included in the Selectmen's budget to be submitted to the Finance Committee in January for Fiscal Year 2022. Board Members stated they would consider this request as they move forward in the the budget process. Ms. Bryant asked to work with the Town Administrator and Town Planner to continue to research and develop a position description, pay range and organization structure for a Sustainable Director and to report back to the Board of Selectmen in January.
