**FY2022 STATE OF THE TOWN.** Stephen Poulos, Finance Director, appeared before the Board to present the 2021 State of the Town. gave a presentation concerning the projected financial status of the town for FY23. The Town is facing increased financial difficulties as FY22 progresses and planning for FY23 begins. While the Town is currently in good financial health, difficult decisions will need to be made for FY23 and beyond to ensure continued fiscal stability. The Town will continue to take proactive steps to ensure future fiscal stability.
