**ESSEX COASTAL SCENIC BYWAYS. Sign Plan.** Rebecca Cutting, Town Planner, appeared before the Board to present the Essex Coastal Scenic Byway Signage Plan. Marblehead is one of thirteen communities on the Essex Coastal Scenic Byway, which is approximately 90 miles and begins in Lynn and travels up the coast to Salisbury. In 2009 the Board of Selectmen appointed a board to determine the route within the town. The project is overseen by the Essex National Heritage Commission. The sign project which involves planning, fabrication and installation is being funded by a grant from the Federal Highway Administration and the Massachusetts Department of Transportation. The sign installation will be completed by June 30, 2016. Motion made and seconded to send a letter to the Essex National Heritage Commission approving the Essex Coastal Scenic Byway Signage Plan as prepared by Greenman-Pedersen Inc. All in favor.

3. Safety cones should be used at the corner of Elm and Cowell during working and school hours to alert drivers, school children and pedestrians.
4. Receipt of the required Certificate of Insurance.
