ABBOT HALL TOWER PROJECT. Timeline. The Town Administrator updated the Board on the Abbot Hall Tower Project. MASSACHUSETTS DEPARTMENT OF TRANSPORTATION. Winter Rapid Recovery Road. The Board received notification from MassDOT that \$40 million dollars has been awarded for a statewide program to assist cities and towns in road repairs. Marblehead will receive \$67,104.00 dollars to be used on projects that may include patching of potholes, cracking and other surface defects, including paving projects, repair and replacement of signage, guardrail, storm grates or road striping or painting.
