1. 8 Stacey St.

Old North Church

This is a Public Hearing for: Replace fence around perimeter of parking lot. Issues discussed include: Applicant has decided to refurbish existing fence vs. replacement.

It was moved, seconded, and voted (5-0 Mrs. Sands recused herself) that no estates are materially affected and to grant a Certificate of Appropriateness for: All work as proposed.

2. 10 State St.

Paula & George Dorr

This is an application for: Replacement of double hung window sash 6 over 6. Mullions to be 1/8" larger. 3/4" wide instead of 5/8".

Issues discussed include: Four windows are visible from a public way. Applicant does not have any photographs or supporting documents.

It was moved, seconded, and voted (5-0) to continue the proceedings to August 7^{th} , 2012 at 7:15 p.m.

3. 13 Hooper St.

Ursula Kretschman

This is an application for:

- •Remove arch from top of chimney.
- •Cut out and tuck point entire chimney above roof line.
- •Install new concrete crown.
- Seal lead flashings.
- •Install stainless chimney cap.

Issues discussed include:

Chimney must be repaired.

- No concrete crown
- No stainless cap

It was moved, seconded, and voted (5-0) that no estates are materially affected and to grant a Certificate of Appropriateness for: Work as proposed but with the following amendments/restrictions:

- •Do not remove arch top detail.
- •Do not install concrete crown.
- Do not install stainless cap.

4. 1 Doak's Lane

This is an application for: Build new garden gate & bench.

Issues discussed include: Fence appears large and is detailed with a large circle that is uncharacteristic of the existing house. Draws focus to connection between former existing structures.

It was moved, seconded, and voted (5-0) that no estates are materially affected and to grant a Certificate of Appropriateness for: All work as proposed but with the following amendments/restrictions: Fence to have shallow concave scallop top. See revised drawing.

5. 34 Orne St.

This is an application for: Install new granite cobble apron.
