# Nancy Parker

This is a hearing on an application for: Replacement of an existing wood shingle roof with architectural asphalt shingles.

**Issues discussed include:** Wood shingles vs. asphalt shingles. House is 1970's era so historic value is not very high.

It was moved, seconded, and voted (5-0) that no material estates are affected and to grant a Certificate of Appropriateness for: Replacement of existing wood shake roof with 3 tab architectural asphalt, 30 year minimum roof shingles.

# 2. 235 Washington St.

## Sean Finn

This is a Public Hearing on an application for: Replacement of 15 windows and a new addition at the rear third (3<sup>rd</sup>) floor, including a new standing seam metal roof. (Low profile 1-1.5 " seams.

Issues discussed include: Building was built 1850. Metal roof is atypical for Old Town. There are some examples, but most are commercial properties. Style of proposed windows is Craftsman which is not appropriate for 1850's house. Stating opposition: Sandy 20 Nicholson St. Has strong concern that metal roof is out of character and not a as aesthetically appealing as shingle roof.

It was moved, seconded, and voted (3-0) that no material estates are affected and to grant a Certificate of Appropriateness for: 1. Replacement and enlargement of upper (main) roof with architectural 3 tab asphalt shingles (30 year minimum) 2. Replacement of two (2) lower secondary roofs (porch at front and left side stair) with standing seam copper roofs. 3. Replacement of 15 windows with wood, simulated divided lites w spacer bars, 6 over 1, architectural series windows.

#### 3. 150 Front St.

#### **Scott Howard**

This is a Public Hearing on an application for: Conversion of an existing three family home to a single family. Addition of two new carriage style garage doors. Addition of a portico over an existing exterior door, Replacement of existing concrete apron with new brick, herringbone pattern.
