1. 28 Pearl St.

This is an application for: Replace existing fences of different types with new, all stockade fence of heights up to 6 ft.

It was moved, seconded, and voted (5-0) that no estates are materially affected and to grant a Certificate of Appropriateness for: All work as applied for. Fence not to exceed 6 ft.

This is an application for: Replace existing 3 tab asphalt with new architectural shingles.
