**PARKING RESTRICTIONS.** Pleasant/Essex Street. Motion made and seconded to authorize the Police Chief, in consultation with the Town Administrator, to restrict parking as needed on a portion of Essex Street, next to the Tourist Booth, during construction. **LICENSING. 1 One Day Liquor License(s). - Delivery of and receipt by the Licensing Authority of Proof that the alcohol will be purchased from an authorized source.
- Proof that the applicant can receive proper delivery; provide proper storage and disposal of all alcoholic beverages purchased all in accordance with the requirements of G. L. c. 138.
