## **MINUTES, May 31, 2022**

Public Hearing – Rules and regulations relative to the keeping of fowls within the Town of Marblehead.

The Board discussed in detail the rules and regulations of keeping fowls in the town. The eleven page document includes the following sections: Authority, Purpose, Supplementary Definitions, General Requirements, Permitting and Application Requirements, Minimum Standards for the Keeping of Fowl, Permit Conditions, Suspension and Revocation, Hearings, Penalties, Enforcement and Severability. A few corrections were made to the language by the Board.

The notice of intent to file application for permit to keep fowl document was reviewed by the Board. This is a letter that is sent to all abutters of the applicant to notify of the application and hearing date.

The application for a permit to keep fowl was the next document reviewed. This two page document includes: address, type of fowl, year round or temporary. The application fee is \$25 and yearly renewal is also \$25.
