Andrew reported that as of June 9<sup>th</sup> the total amount of COVID-19 cases in town is 4046; 64 active cases; 13 probable cases. The average daily incidence rate per 100,000 = 39.4 (lower); total tests to date = 111,977; tests (PCR) in last 14 days = 1,278; percent positive = 8.84% (lower). The cases per age group are as follows:

### Fowl Permit Application – 17 Haley Road

Yael Magen, Esq. for the Joyce family came before the Board to review the application. She reviewed all the steps for the application that the applicants have completed i.e.: application, notice of intent letter to abutters and receipt from post office. She went on to say the applicants have done extensive research. They have spoken to the Conservation Commission and Environmental Agencies. She noted the chickens will be in a coop. The noise level would be similar to a dog or child. Other concerns can all be addressed as requested. The coop and surrounding area can be inspected by the health department if needed. Andrew asked a few questions regarding: bait stations, manure and feeding of the fowl.

The Board began discussing the fowl permit application. They all noted that this is a tough decision. Many abutters brought up the point about coyotes, rodents, odor and health and safety of the neighborhood. Andrew stated to the Board that if fowl permit is granted then a building permit is then required and an inspection of the structure and upkeep is done. Any complaints that may arise they are handled immediately. A permit can be suspended or revoked at any time. Helaine reminded the abutters that they are protected as outlined in the regulations. Currently, there are twelve fowl permits in town with only one complaint addressed in five years.

**MOTION** to grant fowl permit to Danelle and Brian Joyce of 17 Haley Road. On a polled vote the Board voted as follows: Ms. Joanne Miller, in favor; Mrs. Helaine Hazlett, in favor; Dr. Todd Belfbecker, in favor.

Helaine asked Mr. Joyce to be a good neighbor and secure the trash situation.

Ron Fox and Betsy Morris came before the board to discuss Seaglass Village. It is a local community of seniors helping each other to maintain their independence while aging in their own homes. The organization began twenty years ago and there are 300 villages across the nation. Volunteers can provide rides to doctor's appointments, shopping and assist in household projects etc. The Board thanked them for coming to discuss the services provided. Joanne asked for Seaglass Village to come to the Mental Health Task Force in the fall to make a presentation.

### Transfer Station Update

Jerry Smith reported that the traffic flow study has been done at the transfer station. The engineering company VHB was asked to evaluate two possible traffic patterns: commercial use entering on Beacon

Street or commercial and residential using the Green Street entrance for ingress and to egress on Beacon Street. VHB will come before the Board to make a presentation.

Joanne gave an update on the Marblehead Mental Health Task Force. The May 16<sup>th</sup> Cinco de Mayo event was very successful. There were 100 attendees and a panel discussion followed with a team of mental health professionals. Turning off the television was a big focus of the event. A fall program is being planned with NAN Project which promotes mental health awareness and suicide prevention programs for young people, using a peer-to-peer model. The task force will resume in the fall. Marbleheadcares.org is the website that provides all information pertaining to the task force.

#### Director's Report

- \$2000 fine given to a Marblehead Village Market for second violation of selling tobacco to minors. Also, a seven day suspension of tobacco license was issued.
- Beach testing has begun for the season. Gashouse Beach remained closed due to high contamination readings.
- Regular trash and recycle curbside collection on the Juneteenth holiday.
- Household Hazardous Waste collection went well with 140 residents participating.

**MOTION** to approve the \$2000 fine issued to the Marblehead Village Market for selling tobacco to minors. On a polled vote the Board voted as follows: Ms. Joanne Miller, in favor; Mrs. Helaine Hazlett, in favor; Dr. Todd Belfbecker, in favor.
