Meeting called to order at 7:30 pm.

Benjamin Day came before the Board to give an update on the Marblehead Counseling Center. The center will be celebrating 50 years of service to the community. In 2018, the center saw 400 individuals a month of which 67% were Marblehead residents. Moving forward the goal is to see 500 individuals a month with more therapists available more individuals will be seen.
