**CHAMBER OF COMMERCE. Tree Lighting/Decorations.** Beth Ferris, Executive Director, and George Barbuzzi, President, Chamber of Commerce, appeared before the Board seeking approval for various holiday events. Motion made and seconded to approve the request from Beth Ferris, Chamber of Commerce, for the following requests subject to receipt of the required Certificate of Insurance:

**Annual Tree Lighting -** Friday, December 2, 2016 at the National Grand Bank parking lot. Event starts at 6pm, tree lighting at 7pm.

Holiday Wreaths/Red Bows/Ribbon Wraps/Cards. Hang approximately 70 holiday wreaths on light posts in the Historic District and to hang red bow & ribbon wraps, with a 4x6 acknowledgment card limited to text only, on U channel sign posts throughout the other business districts starting the week of November 14, 2016 subject to approval from the Marblehead Municipal Light Department and receipt of the required Certificate of Insurance. All decorations shall be removed by January 6, 2017.

**Holiday Lighting.** Turn on the holiday lights at the Old Town House and State Street Landing by Friday, November 18, 2016. All in favor.

**MINUTES.** Motion made and seconded to approve the minutes from August 24, 2016. All in favor.

**FORT SEWALL. Permission to Use.** Motion made and seconded to approve the request from Kevin Koshy, 1 Cliff Street, to use Fort Sewall on Friday, May 12, 2017, from 4:00 p.m. – 7:00 p.m., and to serve light refreshments and soft drinks for approximately 50-75 people and to erect a properly sized tent, subject to the usual rules, regulations, fees, permits (tent) and receipt of the required certificate of insurance. The park is to remain open to the public at all times. All in favor.

- 2. Delivery of and receipt by the Licensing Authority of Proof that the alcohol will be purchased from an authorized source.
- 3. Proof that the applicant can receive proper delivery; provide proper storage and disposal of all alcoholic beverages purchased all in accordance with the requirements of G. L. c. 138.

**PERMISSION. Old Town House**. Motion made and seconded to approve the request from Vicki Staveacre to serve beer/wine, at no cost, at the Old Town House on Friday, September 16, 2016 from 5:30 p.m. – 7:00 p.m. subject to receipt of the required Liquor Liability Insurance. All in favor.

**OLD TOWN HOUSE. Permission to Use. Marblehead Museum**. Motion made and seconded to approve the request from Pam Peterson, Director, to use the Old Town House on Thursday, September 29, 2016 from 5:00 p.m. – 10:00 p.m. for a lecture series subject to the usual rules, regulations, fees and receipt of the required Certificate of Insurance and to waive the rental fee for this event. All in favor.

**MARBLEHEAD FIRE DEPARTMENT. Retirement**. **ZONING BOARD OF APPEALS. 263-269 Pleasant Street**. Jim Landergan, 273 Pleasant Street, Phil Mancusco, 6 Mohawk Road and Frank McElroy, 3 Front Street, counsel for abutters, addressed the Board as it relates to the appeal that has been filed: 263-269 Pleasant Street, LLC v. Marblehead Zoning Board of Appeals, asking the Board to allocate funds for the town to defend the Zoning Board of Appeals. Lisa L. Mead, Special Town Counsel addressed the Board stating that Special Town Counsel has been directed to defend the Zoning Board of Appeals and would not discuss the Town's litigation strategy at this time.
