ARTICLE 40. Fair Use of Leaf Blowers. Amendment. Motion made and seconded to support an amendment to Article 40, Fair Use of Leaf Blowers, exempting Town Employees, if it passes Town Meeting. All in favor.

MARBLEHEAD PUBLIC SCHOOLS. Superintendent. Motion made and second to allow the Chair to address any questions at Town Meeting regarding the School Committee and the Search for the next School Superintendent. All in favor.

ARTICLE 37. Landfill Closure/Temporary Construction Takings / Remediation's. Motion made and seconded to support Article 37 at Annual Town Meeting 2013. All in favor.

PERMISSION. Pump Jack Staging. Washington Street. Motion made and seconded to approve the request from David Ottinger to have Pump Jack staging with netting at 47 Washington Street for an initial 2 weeks subject to approval from Chief Picariello and receipt of the required Certificate of Insurance. Delivery trucks will be making stops over this time period as well. Washington Street must remain open at all times to allow for emergency vehicles and busses to pass through. Mr. Ottinger should contact the Town Administrator after the initial 2 week period with an update on the project and request for further time if needed. The exact dates to be coordinated with the Town Administrator. All in favor.

CUBMOBILE. Philips Road. Motion made and seconded to approve the request from Amy Leveroni, 299 Ocean Avenue, to hold the annual Cub-mobile race on Philips Road, Saturday, May 18, 2013 from 4:00 p.m. – 6:00 p.m. with a rain date of Sunday, May 19, 2013 from 3:00 p.m. – 5:00 p.m. All in favor. Residents will be allowed in and out of their driveways as needed.

MASSACHUSETTS DIVISION OF MARINE FISHERIES. Recreational Harvesting. Motion made and seconded that effective April 30, 2013 at midnight, the winter season for recreational harvesting of surf clams has ended. The areas affected are Devereux, Tuckers and Goldthwait Beach. All in favor.

RESERVE FUND TRANSFER. Public Buildings. Motion made and seconded to authorize the Building Commissioner, Robert Ives, to appear before the Finance Committee to request the transfer of the sum of \$12,500.00 from the Reserve Fund in accordance with Chapter 40, Section 6 of the Massachusetts General Laws for salaries. All in favor.
