MINUTES. Motion made and seconded to approve the minutes from October 9, 2013. All in favor.

Chair Belf-Becker recused herself from the Meeting.

CHAIRMAN PRO TEMP. Motion made and seconded to appoint Judith R. Jacobi Chairman Pro Temp for the Finance Committee Interviews. All in favor.

FINANCE COMMITTEE. Interview. Appointment. Emily Belfbecker, 65 Glendale Road, appeared before the Board seeking a position on the Finance Committee. Motion made and seconded to appoint Emily Belfbecker to the Finance Committee with a term to expire in May 2016. All in favor.
