MARBLEHEAD PUBLIC SCHOOLS. STATEMENT OF INTEREST. Maryann Perry, Superintendent of Schools, and Ken Lord, Executive Director of Technology and Operations, appeared before the Board to update them on the Gerry School project. Last year the School Committee submitted a Statement of Interest to the Massachusetts School Building Authority (MSBA). The Town has been notified that the Gerry School has been accepted into the Eligibility Period for the building program. An article will be before Town Meeting in May 2016 seeking funding for a feasibility study all in accordance with MSBA requirements. **RECREATION AND PARKS DEPARTMENT. Revolving Funds.** Motion made and seconded to approve the request from Tim Short, Superintendent, Recreation and Parks Department, to reauthorize its Revolving Fund for \$600,000 for fiscal year 2017 in accordance with Mass General Laws Chapter 44, Section 53E ½. All in favor.

**BOARD OF HEALTH. Revolving Funds.** Motion made and seconded to approve the request from Andrew Petty, Director of Public Health, to reauthorize the revolving fund dedicated to commercial waste disposal in the amount of \$450,000 for fiscal year 2017. Expenditures from the fund by the Board of Health will be for the cost of solid waste disposal and receipts of the fund will include commercial disposal receipts in accordance with Mass General Laws Chapter 44, Section 53E ½. All in favor.

**BOARD OF HEALTH. Revolving Funds.** Motion made and seconded to approve the request from Andrew Petty, Director of Public Health, to establish a new revolving fund dedicated to vaccine in the amount of \$8,000 for fiscal year 2017. Expenditures from the fund by the Board of Health will be for the cost of vaccine receipts and receipts of the fund will include commercial vendor receipts in accordance with Mass General Laws Chapter 44, Section 53E ½. All in favor.

**DEPARTMENT OF PUBLIC WORKS. Revolving Funds.** Motion made and seconded to approve the request from Arthur Graves, Director of Public Works, to establish a new revolving fund account to be used for deposit fees collected from entities that open various public ways for purposes of utility work, not to exceed \$40,000, for fiscal 2017 in accordance with Mass General Laws Chapter 44, Section 53E ½. All in favor.

**CONSERVATION. Revolving Funds.** Motion made and seconded to approve the request from William C. Lanphear, Engineering and Conservation Administrator, to reauthorize the Conservation Fines Revolving Fund in the amount of \$10,000 for fiscal year 2017 and the Storm Water Bylaw Revolving Fund in the amount of \$10,000 for fiscal year 2017 in accordance with Mass General Laws Chapter 44, Section 53E ½. All in favor.

MARBLEHEAD HISTORICAL COMMISSION. Revolving Funds. Motion made and seconded to approve the request from Chris Johnston, Chairman, to reauthorize the Historical Commission Gift Shop Revolving Fund in the amount of \$17,000 for fiscal 2017 in accordance with Mass General Laws Chapter 44, Section 53E ½. All in favor.

MARBLEHEAD HISTORICAL COMMISSION. Revolving Funds. Motion made and seconded to reconsider the previous vote for the Historical Commission Revolving Fund. All in favor. Motion made and seconded to approve the request from Chris Johnston, Chairman, to reauthorize the Historical Commission Gift Shop Revolving Fund in the amount of \$15,000 for fiscal 2017 in accordance with Mass General Laws Chapter 44, Section 53E ½. All in favor

**DESIGNATED EMPLOYER REPRESENTATIVE**. Motion made and seconded to create the position of Designated Employer Representative which shall also be designated as a special municipal position pursuant to Massachusetts General Law Chapter 268A section 1, clause n. All in favor.

**SPECIAL MUNICIPAL POSITION. Exemption**. Motion made and seconded to grant Paul Jalbert an exemption from Massachusetts General Law Chapter 268A, section 20, to allow him to hold the special municipal position of Designated Employer Representative. All in favor.
