MINUTES. Motion made and seconded to approve the minutes from November 30, 2011. All in favor.

WARRANT ARTICLE. Section 17A, Alcoholic Beverage Control Commission. Rules and Regulations. Robert C. McCann, representing the Eastern Yacht Club, appeared before the Board asking the Board to sponsor an article for 2012 Annual Town Meeting to adopt section 17A of the Alcoholic Beverage Control Commission (ABCC) Rules and Regulations, giving the Town discretion, but not obligated, to convert a seasonal license to a full year license. Any license that is converted "stands above" the annual licenses and does not count against the statutory limits that the Town has.
