MINUTES. Motion made and seconded to approve the minutes from May 12, 2010. All in favor.

VETERANS' AGENT. David C. Rodgers, Veterans' Agent, appeared before the Board to announce the Memorial Day Weekend schedule which is as follows: Saturday, May 29th 11:00 a.m. – Grave flagging at Waterside Cemetery, meet at the Bell Tower. Sunday, May 30th 1:00 p.m. Veterans service at Star of the Sea Cemetery, Monday, May 31st Memorial Day, 8:00 a.m. – Clark Landing Service, 9:00 a.m. main parade begins and continues to Waterside Cemetery. Guest Speakers at Waterside Cemetery will be Don Nowland, West Point Graduate and retired Col. in the Army and Steven Mitchell, Petty Officer, 1st Class, US Navy. Grand Marshall of the parade will be Robert Glabicky, US Army, Korea. Trolley service will be available from the VFW at 7:30am for all Veterans who may need assistance to participate in the activities. The VFW will be providing lunch after the ceremony. The public is invited and encouraged to attend all ceremonies.

LEAVITT AWARD. Independent Living Center of the North Shore & Cape Ann, Inc. Lloyd Caswell, 101 Farrell Court, appeared before the Selectmen. Lloyd was recently honored by the Independent Living Center of the North Shore & Cape Ann, Inc. at the 23rd Annual Legislative Breakfast held on May 14, 2010. Lloyd received the prestigious Leavitt Award, given to an individual with a disability who by his actions and accomplishments has done the most to promote the ideals of independent living. Lloyd thanked Mary Levine, Co-chair Disabilities Committee, for nominating him and the Board of Selectmen for their continued support throughout the years.

RESERVE FUND TRANSFER. Highway. Motion made and seconded to authorize Town Administrator Anthony M. Sasso to appear before the Finance Committee to request the transfer of the sum of \$3,000.00 from the Reserve Fund in accordance with Chapter 40, Section 6 of the Massachusetts General Laws for Highway Expenses. All in favor.

CONTRACT. Abbot Hall. Vote. Motion made and seconded to award a contract to Stevenson services of Bristol Connecticut for the repair and replacement of windows at Abbot Hall in the amount of twelve thousand seven hundred and thirty one dollars (\$12,731.00) to be paid for by the Historical Commission and authorize the Chairman to sign on behalf of the Board. All in favor.

PERMISSION. Salem YMCA Witch City Triathlon. Motion made and seconded to approve the request from Elizabeth Schultz, Salem YMCA, to hold their Annual Witch City Triathlon on Sunday, August 8, 2010 from 7:00 a.m. - 11:00 a.m. subject to approval from the Marblehead Police and Fire Departments and receipt of the required Certificate of Insurance. The event begins with a swim at Forest River Park at 7:00 a.m. followed by a bicycle race through Marblehead, entering on Lafayette Street to Pleasant Street to Ocean Street and then three times around Marblehead Neck returning via Ocean Avenue to Pleasant Street, Lafayette Street back to Forest River Park. The run will occur on the bicycle trail beginning in Salem off Lafayette Street. All in favor.

OLD TOWN HOUSE. Polling Location. Accessibility Compliance. Robin Michaud, Town Clerk, appeared before the Selectmen to advise them that she has been notified by the Commonwealth that the Old Town House no longer meets the requirements of 950 CMR § 51.00 as a polling location. The Town Clerk's recommendation to the Board is to move Precinct 1 to the Community Center for the upcoming Special Election on June 15, 2010. Voters in Precinct 1 need to be notified 10 days prior to the election of the change in polling location. After discussion with the Board motion made and seconded to have Town Counsel seek a waiver from the Commonwealth to hold the Special Election on June 15, 2010 at the Old Town House and to then determine how to make the Old Town House accessible for future elections. 1 voted in favor. 4 voted opposed. After discussion motion made and seconded to have Town Counsel look into the Waiver process. All in favor.

SISTER CITY LIAISON. Grasse, France. Appearing before the Board: Myriam Zuber, 10 Village Street, Sister City Liaison, Wendy Soucy, Marblehead High School Lead Teacher-Foreign Language, MHS Students, Sophie Katzman and Seth Jalbert. Ms. Zuber expressed her thanks to the Board and her committee members for their work and support on the reactivation of the Sister City Partnership between Marblehead and Grasse, France. Ms. Zuber noted that the delegation from Grasse was deeply moved and appreciative to the Town throughout the events held on May 20- 22, 2010. Wendy Soucy took the opportunity to integrate the reactivation program into her French classes at the High School, initiating a very successful "pen pal" program with students in Grasse. Sophie Katzman and Seth Jalbert further pursued their interest and did their Senior Projects on Grasse. Sophie worked with French students and designed a poster board presentation of stories and poems based on what they learned of Admiral de Grasse and the Marquis de Lafayette. Seth Jalbert created a painting depicting Admiral de Grasse and General Washington overlooking overlapping scenes from Marblehead and Grasse. Motion made and seconded to send a letter of thanks to the Sister City Committee for preparing a wonderful program of events for the Town. All in favor. Motion made and seconded to send a letter of thanks to the Senator-Mayor Jean-Pierre Leleux, for his gift, a book entitled "Perfume,

A Global History". All in favor. Motion made and seconded to give the book to the Abbot Public Library to be placed in the Marblehead Room. All in favor.
