## MINUTES August 11, 2010

**APPOINTMENT. Chairman Pro- Tem.** Motion made and seconded to appoint Mrs. Belf-Becker as Chairman for this meeting. All in favor.

**PERMISSION.** Pavers on Town Property. Alan Chipman, 12 Dodge Road, and Michael Baizen, 12 Jane Road, Contractor, appeared before the Board seeking a onetime exception to allow driveway pavers to continue from the driveway to the street at 12 Dodge Road. Mr. Chipman presented the proposed plan for the pavers and Mr. Baizen concurred with the specifications presented.
