**SHELLFISH CONSTABLE. Applicant.** A letter of interest was read from Doug Percy as it relates to serving as a Shellfish Constable. Motion made and seconded to appoint Doug Percy as Shellfish Constable with a term to expire in May 2009. All in favor.

**VOTE.** Motion made and seconded to present a Proclamation from the Town of Marblehead to Maureen McKinnon-Tucker on Saturday, September 20, 2008. All in favor.

**VOTE.** Motion made and seconded to place a sign entering the Town of Marblehead in honor of Maureen McKinnon- Tucker to read as follows: “Home of 2008 Paralympic Sailing Gold Medalist Maureen McKinnon-Tucker”. All in favor.
