**MINUTES**. Motion made and seconded to approve the minutes of March 28, 2007. All in favor.

**PERMISSION.** WALK. Kurt A. James, 56 Norman Street was present to ask permission to have the first annual Marblehead Interfaith Youth 5K/10K Hunger Walk on Sunday, May 6 starting at 2 p.m. (Registration to start at 1:30 p.m. at National Grand Bank) Proceeds to benefit the Marblehead Food Pantry. Motion made and seconded to approve subject to no permanent markings being made on the streets of our Town. All in favor.

**LICENSING.** One Day Liquor License. Amendment. Motion made and seconded to amend the previously approved license issued to Michael and Laura Tyrrell, Ballast Lane. Permission is changed from wine and beer to all alcohol. All in favor.

**LICENSING.** One Day Liquor License. Request from Doug Hill, Vice President, Marblehead Little Theatre for a liquor license to serve alcohol at the Theatre on Friday, April 13, 2007 between the hours of 8:00 p.m. and 11:00 p.m. Motion made and seconded to approve the request subject to the receipt of the requisite fee and insurance. All in favor.

**PERMISSION. Blocking Street. Red Frank Lane.** Request from Douglas O'Leary, 48 Commercial Street to block Red Frank Lane on Saturday, May 19 from 8:00 a.m. to 12 noon. for a yard sale. Motion made and seconded to approve. All in favor.

**LICENSING. Entertainment. Atlantic Avenue.** Jeff Flynn, Flynnies on the Avenue, 28 Atlantic Avenue was present to request a license for the following entertainment: All kinds of music. Guitar with amplifier – two people maximum.

Mondays through Saturdays (no Sundays) with expectation that entertainment will occur only one to two nights a week – once or twice a month. Hours: 8:00 p.m. until 11:45 p.m. Motion made and seconded to approve the request subject to entertainment not being heard from the street. All in favor.

**PERMISSION. Filming. Parking Restrictions. Washington Street. Amendment**. Motion made and seconded to amend the previously approved parking restriction requested by Anna Saraceno, Nancy Porter Productions Inc., Lexington, MA. Permission is changed from May 18 to May 25 for parking to be restricted on Washington Street, in front of Lee Mansion, from the driveway of Litchman's Printing to the corner of Rockaway Street during the hours of 6 am to 8 pm. All in favor.

**PERMISSION. Bell-Ringing.** Letter from Don Orne, Jr. requesting to ring the bell at Abbot Hall for five minutes on National Prayer Day (Thursday, May 3) directly after the noon-time toll. Motion made and seconded to approve the request. All in favor.

**LICENSING.** Cat Island. Fish Trap. Application from Douglas Heath, 2 Millets Lane, Manchester, MA for authorization to place a floating fish trap off the tidal waters of Cat Island. (Mr. Heath's current authorization, for a term of three years, expires on June 27, 2007.) Motion made and seconded to approve the application. All in favor.

Marion Keating were present in connection with a presentation featuring Chris and Toren Volkmann coauthors of "From Binge to Blackout". LICENSING. Public Hearing. Maddie's Sail Loft. A hearing to determine if Maddie's Enterprises, Inc. d/b/a Maddie's Sail Loft ("Licensee") has violated MA General laws, Chapter 138, Section 64 and/or the town's rules and regulations with respect to over-serving of alcoholic beverages to its patrons and to determine if the all alcoholic beverages as a common victualer license issued to Licensee should be suspended or revoked. Town Counsel Marc Miller opened the hearing and summarized incidents prior to this date that warranted the calling of a public hearing specifically one that occurred on March 25 at 19:36. John Tangusso, President of Licensee was present with Jayne Tangusso, the manager of Maddie's Sail Loft. Mr. Tangusso spoke and presented written material to the Selectmen to support why the incident of March 25 did not relate to Licensee and what he has done to date and plans to do to educate his wait staff on the serving of alcoholic beverages. After review of the material and discussion a motion was made and seconded to take no action. On a polled vote the Selectmen voted as follows: Mr. Nye: in favor; Mrs. Belf-Becker: in favor; Mrs. Jacobi: in favor; Mr. Shribman: in favor and Mr. Christensen: in favor.

**POLICE DEPARTMENT. Police Chief Search.** Town Administrator Anthony M. Sasso reported that the Sole Assessment process will commence tomorrow and end Friday. Test results are expected by April 24 and the Selectmen's vote, to appoint a new Police Chief, is tentatively planned for April 25.

Mr. Christensen recused himself from the meeting at 8:38 pm due to a potential conflict of interest regarding the ensuing conversation.

**CHAIRMAN. Pro-Tem.** Motion made and seconded to appoint Jeffrey Shribman as Chairman during the discussion relative to the Police Chief search process.

**POLICE DEPARTMENT. Police Chief Interview Process.** Marc Miller, Esq. was present to give the Selectmen guidance on establishing a fair, open, effective and appropriate interview process to be utilized to select a new Police Chief.

Mr. Christensen returned to the meeting at 9:18 p.m.

**EXECUTIVE SESSION.** Motion made and seconded to go into Executive Session for the purposes of considering the purchase and/or value of real property, votes may be taken, and if they are, votes will be released at a time deemed appropriate by Counsel, not to resume in open session. On a polled vote, the Board voted as follows: Mr. Nye: in favor; Mrs. Belf-Becker: in favor; Mrs. Jacobi, in favor; Mr. Shribman: in favor and Mr. Christensen: in favor.

Motion made and seconded to adjourn at 9:25 p.m. All in favor.
