February 28, 2007

Board met in Regular Session at 7:30 p.m. in its Meeting Room in Abbot Hall.

MINUTES. Motion made and seconded to approve the minutes of February 16, 2007. All in favor. Mrs. Jacobi voted present.

STATE REPRESENTATIVE DOUGLAS W. PETERSEN was present to advise the Board that he will be requesting funds to rebuild the causeway seawall and the bridge repair at Village Street.

PUBLIC HEARING. Annual Town Meeting. Warrant Article 48 – Layout and Acceptance of Tioga Way. Paul M. Lynch, Esq., attorney for the petitioner of Article 48 (Robert E. Hansen, 32 Tioga Way and others, the “Petitioner”) were present to request the Selectmen’s support of this article. Dana Snow and Doug Saal were present to recommend against the acceptance of Tioga Way at this time due to the poor condition of the road. Mr. Hansen and the following persons were present and spoke in support of the acceptance: Rosanne Phelan, 77 Pleasant Street and Antonio Musso, 6 W. Cottage Street. Mssrs. Hansen and Musso are part owners of the commercial development. Ms. Phelan is a tenant at the development. Motion made and seconded to not accept Tioga Way at this time. Four in favor. One opposed. After discussion, a motion was made and seconded to reconsider this vote. All in favor. Motion made and seconded to continue the hearing to 7:35 p.m. on April 25 for the Petitioner to make the appropriate repairs to Tioga Way as recommendation by Mssrs. Snow and Saal. All in favor.

PERMISSION. Walkathon. Request from Erin Mondello, Executive Director of BANE CARE to hold the 2nd annual Devereux House Mosaic Memory Walk Around the Neck” scheduled for Saturday, June 2, 2007. Proceeds to be divided between The Alzheimer’s Association and the Social Enrichment Program for residents of Devereux House. Motion made and seconded to approve subject to:

- 1) the usual insurance requirements;
- 2) Police Department approval; and
- 3) that no permanent markings be made on the street. All in favor.

PERMISSION. Use of Abbot Hall. Cancellation. Notice from Christine Creager-Kepko, President of Marblehead Festival of Arts 2007 to cancel the previously requested and approved plan to use Abbot Hall on March 1, 2007 for the Festival’s annual winter film festival.

PERMISSION. Use of Spirit of ’76 Image. Motion made and seconded to remove from the table the request of Adam Bissonnette, NXTevent. All in favor. No action taken on his request.

LOCAL ELECTION. May 2007. Mr. Shribman announced that he will not be seeking re-election this year.

EMERGENCY MEDICAL SERVICES COMMITTEE. Mr. Christensen reported that after review he has determined that the committee is to be considered an ad-hoc advisory committee. Motion made and seconded to approve. All in favor.
