MINUTES. Motion made and seconded to approve the minutes of July 18, 2018. All in favor. Motion made and seconded to approve the minutes of July 23, 2018. All in favor.

POLICE DEPARTMENT. Human Resource Request. Chief Robert O. Picariello appeared before the Board to advise the Board that due to a pending retirement he will have a vacancy for a sergeant's position. Motion made and seconded to approve the request from Chief Picariello to obtain a certified list of candidates from the State Human Resources Division, for the purpose of filling a sergeant's position. PARKING REGULATIONS. Crosswalk. **Foster Street**. Motion made and seconded, on recommendation from Chief Picariello, to authorize the Eastern Yacht Club to remove the crosswalk at the former entrance to the pool area on Foster Street at the Club's expense. All in favor.

Motion made and seconded to approve the request from Jennie Sheridan, Seaside Run Club, to hold the annual Full Hearts 5K, to raise funds for the Fit Girls program, on Sunday, November 4, 2018 from 8:00 a.m. – 11:00 a.m. subject to approval from Chief Picariello, School Department, receipt of the required Certificate of Insurance and Police Details. The route will be the same as last year, beginning and ending at the Village School. All in favor.

CHIEF SHELLFISH CONSTABLE. Letter of Interest. A letter of interest was received from Jack Attridge as it relates to serving as the Chief Shellfish Constable. Motion made and seconded to receive letters of interest to serve as the Chief Shellfish Constable. Deadline to submit letters is Friday, September 7, 2018 at 12:00 noon. Submit to Board of Selectmen, Abbot Hall, 188 Washington Street. Applicants will be interviewed by the Board at their meeting on September 12, 2018. All in favor.

EXTREME RISK PROTECTIVE ORDERS BILL (ERPO). The Board received a letter from State Representative Lori Ehrlich notifying the Board that the ERPO Bill was passed by the House of Representatives, concurred by the Senate and then signed by Governor Charlie Baker and thanking the Board for their cooperation on matters local and statewide.

SEPTEMBER 11th. Remembrance Ceremony. Notification was received from Chief Jason Gilliland that the Marblehead Fire and Police Department will join departments and community members across the country with a remembrance ceremony on September 11, 2018 at 10:00 a.m. sharp at Memorial Park to commemorate the 17th anniversary of the September 11th terrorist attacks and the subsequent loss of life suffered at the World

Trade Center, the Pentagon and Shanksville, Pennsylvania. The community is invited to this ceremony.

CURB CUT REGULATIONS. **Request for Reconsideration**. The Board received a letter from Carleton H. Whittaker, 10 Kenneth Road, asking the Board to reconsider his original request for relief, which was denied by the Board on June 27, 2018, and adopt a process change to ease driveway surface deviation approval. The Board discussed his request and do not see their denial of his request as illogical or arbitrary. Motion made and seconded to ask the Town Administrator to write a response to Mr. Whittaker advising him that the Board will not make an exemption to the regulation. All in favor.
