Indigenous Peoples' Day.** Leah Bokenkamp,23 Rowland Street, Holly Jaynes, 3 Countryside Lane, Sherry Gagne, 5 Pleasant Street and appeared before the Board to present an article they have placed on the 2019 Annual seeking to change the name of the 2<sup>nd</sup> Monday in October to Indigenous Peoples' Day.

**WATER & SEWER COMMISSION.** Vacancy. The Board was notified, as required by MGL Chapter 41 §11, of a vacancy on the board. Motion made and seconded to convene a joint meeting of the Board of Selectmen and the Water & Sewer Commission on February 27, 2019 to interview applicants. Applications should be sent to the Board of Selectmen, Abbot Hall, 188 Washington Street, and the Water & Sewer Commission, Tower Way Office Building. Deadline to apply is Monday, February 25, 2019 at 5:00 p.m. All in favor.

**HEARING. Dangerous Dog.** The Town Administrator advised the Board that a public hearing on a dangerous dog was held on Wednesday, February 6, 2019 at 4:00 pm, in accordance with Mass General Laws, Chapter 140, section 157, to determine if the dog residing at 8 Trager Road is a nuisance dog or dangerous dog. Laura Consigliar, Animal Control Officer, was present at the hearing. Testimony was heard from Elena Siniava and the Animal Control Officer as well as from many neighboring residents. Based upon the evidence presented and the recommendations of the Animal Control Officer, the Town Administrator recommended that the Board of Selectmen approve the following conditions to be imposed on Chewie, the dog residing at 8 Trager Road:

- When removed from the premises, Chewie be securely and humanely muzzled and restrained by a three foot or less leash with a minimum of 300lb tensile strength. The muzzle will be worn at all times.
- The owner provide proof of insurance in an amount of, not less than, \$100,000.00 insuring the owner against any claim, loss damage or injury to person, pets or property, resulting from acts, whether intentional or unintentional, of the dog.
- The owner provides information by which Chewie can be identified for the rest of his life, including, but not limited to photos, microchip and a Veterinarian examination.
- Chewie is not allowed to be walked by anybody other than his owner or a certified dog trainer.
- Chewie must be evaluated and trained by a certified trainer.
- The owner of Chewie must go through training with a certified trainer.
- The owner of Chewie shall have him neutered, unless the owner provides evidence by a Veterinarian that the dog is unfit for altering due to a medical condition or upon evaluation by the certified trainer it is determined to be contraindicated.
- Chewie is to be securely confined indoors or confined outdoors in a securely enclosed and locked pen as defined by M.G.L. c.140 §157.
- Chewie cannot be kept in a crate in the garage.
- The Animal Control Officer shall work with the owner to insure these requirements are met.
- Chewie must stay at the Trainer evaluation facility until consent for Chewies release has been received from the Police Chief, Animal Control Officer and Hearing Authority.
- The Board shall notify the owner of the premises of these requirements.

The Board held a lengthy discussion and sought clarification from the Town Administrator and Animal Control Officer on the situation. The Board took public comment from many of the neighbors. The Board expressed their serious concerns regarding the safety of the neighborhood and will hold another meeting and invite the trainer in to review his report and recommendations.

Motion made and seconded to approve the recommendations as presented and to notify the dog's owner in writing. All in favor. Motion made and seconded to send written notification of these requirements to the homeowner. All in favor.
