MINUTES. Motion made and seconded to approve the minutes from February 7, 2019. 4 in favor. Mr. Nye voted present. Motion made and seconded to approve the minutes from February 13, 2019. 4 in favor. Mr. Grader voted present.

JOINT HEARING. Water & Sewer Commission. Interview. Appointment. Members of the Water & Sewer Commission, Carl Siegel, Thomas Murray and Greg Bates, and the Board of Selectmen interviewed Thomas Carroll for the vacant position on the Water & Sewer Board. Motion made and seconded to appoint Thomas Carrol to the Water & Sewer Commission with a term to expire in May 2019. All in favor.

PERMISSION. Use of Images. Motion made and seconded to approve the request from Bethe Moulton to use an image of The Purchase of Marblehead and the WPA mural by T.S. Baker, 1934 in a monograph titled *The Paintings of J.O.J. Frost* and to give credit for these images as provided by the Town. All in favor.

PERMISSION. Run for the Fund 5K. Motion made and seconded to approve the request from Kristen Norman, Chairperson, to hold the annual Run for the Fund road race on Sunday, June 2, 2019 subject to approval from Marblehead Police, Fire, Recreation and Parks Department, police details and receipt of the required Certificate of Insurance. No permanent markings are allowed on the streets and any temporary markings must be removed at the conclusion of the event. All in favor.

CONTRACT. Animal Control Building. Friends of Marblehead Abandoned Animals. Motion made and seconded to award a lease for the main floor of the town owned Animal Control building at 44 Village Street to Friends of Marblehead Abandoned Animals Inc. (FOMAA) for a period of five years in the amount of one dollar (\$1.00) per year for the public purpose of operating a not for profit, no kill, animal shelter that will co-exist and assist the primary purpose of the town's animal control building. LICENSING. One Day Liquor. Friends of Marblehead Public Schools. Motion made and seconded to approve the request from Tracy Orloff, Friends of the Marblehead Public Schools, for a One Day Liquor License on Saturday, June 15, 2019 from 5:30 p.m.

- 9:00 p.m. at 12 Clifton Avenue for the annual Summer Soiree subject to the following:
- 1. Delivery of and receipt by the Licensing Authority of the required fee (\$50.)
- 2. Delivery of and receipt by the Licensing Authority of Proof that the alcohol will be purchased from an authorized source.
- 3. Proof that the applicant can receive proper delivery; provide proper storage and disposal of all alcoholic beverages purchased all in accordance with the requirements of G. L. c. 138.

No permanent markings are allowed on the streets and any temporary markings must be removed at the end of the event. All in favor.

PERMISSION. Firecracker 4 Miler. Motion made and seconded to approve the request from Carol Meyer, Lynch van Otterloo YMCA, to hold the annual Firecracker 5K Certified Road Race on Sunday, June 30, 2019 subject to approval from the Marblehead Police, Fire, Recreation and Parks Department, police details and receipt of the required Certificate of Insurance. No permanent markings are allowed on the streets and any temporary markings must be removed at the end of the event. All in favor.

All in favor.

OLD TOWN HOUSE. Permission to Use. Marblehead Museum. Motion made and seconded to approve the request from Lauren McCormack, Executive Director,

Marblehead Museum, to use the Old Town House on Thursday, May 2, 2019 for a lecture by Dan Dixey, from 6:00 p.m. – 9:00 pm., subject to the usual rules and regulations, fees and receipt of the required Certificate of Insurance and to waive the rental fee for this event. All in favor.

CONTRACT. Front Street Repair Project. Motion made and seconded to amend the contract with N. Granese & Sons for the Front Street Repair Project by extending the completion date to April 30, 2019 with no increase in cost and authorize the Chair to sign the change order on behalf of the Board. All in favor.

HOUSING PLAN ADHOC COMMITTEE.
