STATEMENT. Recent acts of hate in Town. The Board addressed the recent acts of hatred that have taken place in Town. Board members all expressed their disappointment with these acts stating there is no room in Town for this and the Town will not tolerate this behavior. The Chair stated *as a member of the Board of Selectmen I condemn these acts of hate and am saddened that this has happened in our community yet again....I <i>remain committed to speak out against any expression of hate in the community and will continue our collective work to promote tolerance, justice and equality.* Mr. Grader read a prepared statement (attached here). Chief Picariello addressed the Board and related that new incidents had occurred the previous night. The Chief and his department are committed to standing up against this behavior. Helaine Hazlett, Chair, Task Force against Discrimination, thanked the Board and the Chief for their support. The Task Force will soon announce their plans for the 2nd Annual Indigenous People's Day and several live stream events coming up this fall.
