SWEARING IN. Elected Officials. Robin Michaud, Town Clerk, appeared to swear in the newly elected Selectmen. This is the 364th Board of Selectmen for the Town of Marblehead. All newly elected officials were also sworn in by the Town Clerk.

Motion made and seconded to nominate Jackie Belf-Becker as Chair for the coming year. All in favor.

Jackie Belf-Becker continued the meeting as chair.

DISCLOSURE – **Chapter 268A.** Bret T. Murray, Harry C. Christensen, and Jackie Belf-Becker read their disclosures that are required by Chapter 268A Section 23(B)(3) of the Mass General Laws.

MINUTES. Motion made and seconded to approve the minutes from April 18, 2014. All in favor. Motion made and seconded to approve the minutes from April 23, 2014. All in favor. Motion made and seconded to approve the minutes from May 5, 2014. All in favor.

VETERANS AGENT. Memorial Day. David Rodger, Veterans' Agent, appeared before the Board to announce the following Memorial Day events:

Saturday, May 24, 2014. 9:00 a.m. from the Bell Tower at Waterside Cemetery. Veteran's Grave Flagging. All are welcome to join members of the VFW, American Legion, and Submarine Veterans in honoring Marblehead's Veterans. Anyone needing a flag for a Veterans Grave, which was overlooked, may call the Veterans Office at 781-631-0990.

Sunday, May 25, 2014. 1:00 p.m. Veterans Service at Star of Sea Cemetery. Public is welcome.

Monday, May 26, 2014. Memorial Day Parade. 8:00 a.m. Muster at Old Town House. 9:00 a.m. main parade begins; march to Memorial Park then to Waterside Cemetery. Principle Speakers: Memorial Park, David Rodgers, Veterans Agent, US Navy Vet. Trolley service will be available from the VFW at 7:30 a.m. for all Veterans who may need assistance to participate in the activities. The VFW will be providing lunch after the ceremony. The public is invited and encouraged to attend all ceremonies.

POLICE DEPARTMENT. Appointment. Chief Picariello appeared before the Board to recommend the promotion of Sergeant Sean Sweeney to the rank of Lieutenant. Sergeant Sweeney has been a member of the Marblehead Police Department for over 16 years and has served as Sergeant since 2004 and is currently head of the detective unit. Motion made and seconded to appoint Sean Sweeney to the rank of Lieutenant effective May 18, 2014. 4 voted in favor. Mr. Murray voted present.

RESERVE FUND TRANSFER. Police Department. Chief Picariello appeared before the Board seeking a Reserve Fund Transfer. Motion made and seconded to authorize Police Chief Robert Picariello to appear before the Finance Committee to request the transfer of the sum of thirteen thousand and five hundred dollars (\$13,500.00) from the Reserve Fund in accordance with chapter 40, section 6 of the Massachusetts General Laws for Police Expenses. 4 voted in favor, Mr. Murray voted present.

MEMORIAL DAY PARADE. Parking Restrictions. Motion made and seconded to approve the request from Chief Picariello to restrict parking in the vicinity of Memorial Park as needed and to temporarily restrict or redirect traffic flow throughout the entire parade route on Monday, May 26, 2014. All in favor.

DRAINAGE PROJECT. Crosswalks. Traffic and Parking Restrictions. Chief Picariello and Amy McHugh, Water & Sewer Commission, appeared before the Board as it relates to the Drainage Project. The Water & Sewer Commission is in the process of finalizing Phase 1 work that was completed in 2013. Crosswalks in the area will be reinstalled, moved or added. The Board reviewed the plan for this and voted as follows: Motion made and seconded to approve the request from Amy McHugh, Superintendent, Marblehead Water and Sewer Commission, to restore, move and add crosswalks as follows and in compliance with ADA requirements:

- 1. The Crosswalk that was located near 35 Atlantic Avenue (in front of Orange Leaf) will be relocated approximately twenty (20) feet to the sought (before the driveway entrance to Shubie's Marketplace). This will move the crosswalk away from catch basins and out of the way of access to Bank Court.
- 2. The crosswalk located in the area of Atlantic Avenue, Washington Street and School Street (the area known as Five Corners) will be restored to their original positions.
- 3. The crosswalk that was located on Essex Street at Bassett Street will be restored to its original position.

4. A new crosswalk will be installed across from Bassett Street, going from Memorial park to the island that hosts the Chamber of Commerce Information Booth.

All in favor.

TRAFFIC/PARKING RESTRICTIONS. Motion made and seconded to authorize the following traffic and parking restrictions, as it relates to the drainage project, from May 1, 2014 through December 31, 2014, for the following locations and to authorize the Chief, or his designee, to make modifications as needed in order to accommodate necessary changes and/or to better insure public safety:

- Pleasant Street in the vicinity of Essex and Spring Street
- Spring Street in its entirety
- Evans Road between Spring Street and Roosevelt Avenue
- Roosevelt Avenue between Elm Street and the cul-de-sac on Roosevelt Avenue Traffic may be directed, redirected or blocked entirely and parking may be restricted as needed on the area streets to insure public safety and traffic flow. All in favor.

Dawn LaVigne, Atlantic Avenue, George Shube, 2 Richard Road and Mike Hennessey, Atlantic Avenue, addressed the Board with concerns the local businesses have regarding the paving of Atlantic Avenue. Deb Payson, Chamber of Commerce, suggested the Chamber and Water and Sewer set up a meeting with the business owners to discuss the details.

LICENSING. Annual Entertainment. Harbor Light Inn. Peter Conway, Harbor Light Inn, 58 Washington Street, appeared before the Selectmen seeking an annual entertainment license. Motion made and seconded to approve the request from Peter Conway, Harbor Light Inn, 58 Washington Street, for an Annual Entertainment License for non-amplified music, Monday through Sunday, 10:00 a.m. - 10:00 p.m., with the intent of offering entertainment only 1-2x a week. Music should not be heard from the streets. All in favor.

LICENSING. One Day Liquor License. Marblehead Yacht Club. Motion made and seconded to approve the request from Jeannette McGinn, 8 Park Street, Peabody, for a One Day Liquor License at the Marblehead Yacht Club, Cliff Street, on Monday, May 26, 2014 from 5:30 p.m. – 10:00 p.m. subject to the following:

- 1. Delivery of and receipt by the Licensing Authority of the required fee (\$50.)
- 2. Delivery of and receipt by the Licensing Authority of Proof that the alcohol will be purchased from an authorized source.
- 3. Proof that the applicant can receive proper delivery; provide proper storage and disposal of all alcoholic beverages purchased all in accordance with the requirements of G. L. c. 138.

ABBOT HALL. Permission to Use. Rotary Club of Marblehead Harbor. **Holiday Pops.** Motion made and seconded to approve the request from Donald Doliber, Rotary

Club of Marblehead Harbor, to use Abbot Hall for their 17 Annual Holiday Pops Concert on Saturday, December 13, 2014 subject to the usual rules, regulations, fees and receipt of the required Certificate of Insurance on the following dates and to waive the rental fee for this event:

Friday, December 12, 2014 8:00 a.m. – 12:00 noon Saturday, December 13, 2014 4:00 p.m. – 11:00 p.m. Sunday, December 14, 2014 8:00 a.m. – 12:00 noon

All in favor.

FIREWORKS COMMITTEE. 4th of July. A letter was received from Alexander Falk, Chairman, Marblehead Fireworks Committee as it relates to the annual July 4th Fireworks celebration. Motion made and seconded to hold the annual July 4th Fireworks and Harbor Illumination on Friday, July 4, 2014. Harbor Illumination to start at 8:45 p.m. and fireworks at 9:00 p.m. Rain date is Saturday, July 5, 2014. The Marblehead Fireworks Committee is an all volunteer organization and the fireworks display is 100% privately funded. Donations may be sent to the Abbot Hall, Selectmen's Office, 188 Washington Street. Please put "Fireworks" in the memo section. Donations are tax deductible. All in favor.

PERMISSION. Use of Public Way. 147 Front Street. Motion made and seconded to approve the request from Bradley Sontz, President, Max Sontz Roofing Services, Inc., to use the public way at 147 Front Street, the Adams House, to replace the existing roof, subject to approval from the Police and Fire Chief, receipt of the required Certificate of Insurance, approval from the Old & Historic Districts Commission, Conservation Commission and the following:

- Once commenced, work shall be completed in 5 business days. If the project cannot be completed by June 25, 2014 applicant must come back to the Board of Selectmen for further review and approval.
- Debris removal Construction debris "trash shoot" will be used and directed into a movable dump truck daily. Debris shoot will remain and be rested atop scaffolding at day's end securely fastened to existing column. Movable dump truck is allowed on the street from 7:00 am 5:00 p.m. only
- Safety of sidewalk and pedestrian traffic Scaffolding walkway will be erected below debris trash shoot with lights underneath.
- Traffic flow, emergency vehicles and bus traffic shall not be impeded during the project. A police detail will be used during the delivery of materials to better protect the public.

The Town Administrator shall monitor the project for compliance to the above conditions. All in favor.

FORT SEWALL. Permission to Use. Glover's Marblehead Regiment. Motion made and seconded to approve the request from Seamus Daly, Captain, Glover's Marblehead Regiment, to use Fort Sewall Friday, July 11 – Sunday, July 13, 2014 for their annual summer encampment subject to the usual rules, regulations, fees and receipt of the required Certificate of Insurance. All in favor.

ANIMAL CONTROL. Dog Hearing. Motion made and seconded, on advice from Town Counsel, to appoint Town Administrator, Jeff Chelgren, as hearing officer to review and investigate a dog complaint received, in coordination with Chief Picariello, and to report his findings back to the Board. All in favor.

SIGNAGE. Merritt Street. Motion made and seconded to place a "No Large Trucks" sign at the intersection of Merritt and Circle Street. All in favor.

Motion made and seconded to go into Executive Session for the purposes of discussing pending litigation, collective bargaining and the value of real property where the public discussion on the same may have a detrimental effect on the negotiating position of the public body, votes may be taken, and if they are votes will be released at a time deemed appropriate by Counsel.
