1. 8 South St.

Charles Bridges (Tom Jacobs representing)

This is a Public Hearing for: Construct second level addition over existing single story addition as per drawings; Resurface existing open deck with new fir decking and railings; Replace four (4) existing double casement windows using new units of the same size. All new windows and doors to be Marvin wood simulated divided light with spacer bars.

Issues discussed include:

- Inset second floor porch eliminated after previous meeting.
- No persons in support or opposed to the work in attendance.
- · Concerned about adding too much glass area.
- Concerns about French doors.

It was moved, seconded, and voted (3-2) to grant a Certificate of Appropriateness for work as proposed with amendments/restrictions: Skylights eliminated.

2. 54-58 Washington St.

Peter Conway

This is an application hearing for: Paving of parking lot behind Harbor Light Inn. It was moved, seconded, and voted (5-0) that the proposed work is not under the purview of the Old and Historic Districts Commission.

3. 10 Mugford St.

Karyn Lang

This is an application hearing for: Replace picket fence with picket and capped picket design using 36" high red cedar.

6. 12 Waldron St.

This is an application for:

- 1. Replace four windows on first floor (to match condo on left side, 10 Waldron St.) with double hung 50/50 Anderson windows.
- 2. Replace front door.
- 3. Repair front porch and stairs including replacing damaged stairs, railing, and top level. Decking to be mahogany with pressure treated wood used under the structure.

Issues discussed include: This is a 1986 house.

It was moved, seconded, and voted (5-0) that no estates are materially affected and to grant a Certificate of Appropriateness for work as proposed with amendments/restrictions: Windows to match 10 Waldron Court-Confirm they are vinyl clad.

7. 14 Mugford St.
