1. 8 Stacey Street
Flory Denhard
This is a continued application for:

• Fence

Issues discussed include:

2. 21 Beacon Street

This is a new application for:

Windows, roof/rake line

Issues discussed include:

- Applicant proposes to replace existing windows, change existing windows, and extend roof/rake line
- New windows to include all windows at left, front, and right side of house
- All windows to be the same size except as noted on the proposed rendering noted on the application
- The two windows at the right side will be eliminated
- All new windows to be Marvin ultimate wood two over one, simulated divided light window with 5/8" muntins
