#### Recreation and Parks Meeting Minutes

04-26-11

<u>NOTE</u>: The following is a **summary** of matters submitted at a meeting of the Recreation and Parks Commission in accordance with M.G.L Chapter 39 and the Massachusetts Open Meeting Laws. Meetings are often recorded and tapes used as an aid.

1) Call to order: Chairman Chip Osborne called the 04/26/11 meeting to order at 7:00 PM.

#### 2) Attendance:

- a) Present (constituting a quorum): Chip, Derek, Linda, and Sam.
- b) Absent: Chuck.

#### 3) Reports (See attached):

- a) Mike's: No addendum.
- b) <u>Brendan's</u>: **Motion** made and seconded (Linda, Sam) to approve the recommendations (see report) of summer seasonal ground maintenance staff pending the outcome of the required CORI/SORI checks and physical exams; all in favor.

#### 4) Appearances:

- a) Rotary: Tom McNulty appeared to request a rain date for the Rotary's upcoming "Great Race" of Sunday 9/11/11 just in case of bad weather. **Motion** made and seconded (Linda, Sam) to approve the request pending receipt of the proper request form: all in favor. Brendan will ensure the permit is processed.
- b) Family Fund: Kristin Goedkoop appeared to discuss plans for the official opening of the new Gerry Playground (see attached). Kristin was informed that the event as advertised will need: permission to vend food from the Board of Health; insurance; and an approved park permit. After discussion, the board agreed the department can co-sponsor the event to alleviate the need for a permit and private insurance; but BOH approval is still required, and the advertising will need to be changed to reflect the department's sponsorship. Brendan will coordinate with the Family Fund to ensure all required items are in place.
- c) National Grand: Jim Nye appeared to discuss plans for the creation of an employee parking area abutting Memorial Park (see attached concept plan created by Doug Jones). Dave Rodgers was also in attendance as an interested party. Discussion of ideas for trees, shrubs, grass areas, park improvements, funding, irrigation, lighting of flag, and traffic flow ensued. The bank intends to install irrigation for the property and will offer free irrigation of the park to the Town if acceptable. Jimmy's goal is to have the property ready for the 4<sup>th</sup> of July Parade. The Board agreed that they are happy to work with the bank on the project. Brendan will coordinate details.

#### 5) Old Business:

- a) <u>Spring field preparation</u>: Brendan reports all playing fields have been prepared and aeration, seeding, and fertilizing is under way. Irrigation systems are just being put on line. Chip stressed the importance of getting the sprinkler heads marked right away so the fields can be aerated, seeded, and fertilized by the 1<sup>st</sup> week of May. Brendan will coordinate.
- b) <u>Chandler Hovey</u>: Police report distributed for the boards information (attached); no action taken. Brendan reports the Arbor Day project discussed in the 4/5/11 meeting has been coordinated and will be done this weekend.
- c) Beach restrooms: Mike reports they are ready and have been opened.
- d) Bocce court: Still in the planning stages at COA.
- e) Movie night; discussed; no action taken. Board would like to see them come back if feasible.

f) <u>Hamond Center</u>: Chip displayed a concept drawing of the turn-around at Everett Payne. Design, materials, costs, and labor discussed. Chip estimates it will cost no more than \$15,000.00. After discussion, **Motion** made and seconded (Sam, Linda) to allow not more than \$15000.00 be spent on the project from the revolving fund; all in favor.

#### 6) New Business:

- a) Summer field projects: Chip would like to concentrate on needed repairs at Hobbes, "near side" lower Village school, and Seaside. Piper Field was also brought up as a perennial high maintenance field due to poor construction. After discussion, the board asked Brendan to get estimates and prepare proposals for: infield turf; fencing at Hobbes; putting in an automated sprinkler system at Seaside; and outsourcing vs. using Department manpower to replace the infields at Seaside and Hobbes. Chip also requested the Village project be coordinated with the School Department and the affected youth sports organizations to be done in spring 2012. He also noted that Seaside and Hobbes would need to be done either before the hot weather or in the fall and spring to allow grass to take hold; he would like to see Hobbes' done before August 2011, and have Seaside outfield done in fall 2011 and infield done in spring 2012. The need for a water cannon was also mentioned and will be considered as a future capital outlay. The board also agreed the chain prohibiting driving onto Seaside needs to go back up and be left up.
- b) Correspondence (see attached):
  - i) To be determined:
    - (1) Request Interact Club: Jim Nye presented the request for a walk. **Motion** made and seconded (Sam, Linda) to approve pending receipt of a permit application and proof of insurance; all in favor. Brendan will coordinate.
    - (2) Request Carlos Rocha: Board agreed that vending carts or trucks on Park Department properties is prohibited as: many properties already have concession stands; most parks are not open to public vehicle traffic; and any vending contracts would have to be coordinated with the Selectmen as part of a bidding process similar to "Lime Rickey's". Brendan will contact Mr. Rocha.
  - ii) FYI (no actions required): COA letter; Notification to Abutters; Legal Notice; Board of Selectmen letters (2).
- c) Senior Class Carnival: The board agreed that the Carnival can use water from the beach garage.

#### 7) Timekeeping:

- a) 8:56 PM: Motion made and seconded (Sam, Linda) to extend the meeting 15 minutes; all in favor.
- b) Meeting adjournment: 9:02 PM.
- c) Next meeting: After discussion of elections and being sworn in, the next meeting was scheduled for 7:00 PM on Tuesday, May 10, 2011 at the Marblehead Community Center.

# Assistant Superintendent/Director of Recreation Report April 25, 2011

#### RECREATION

Program registrations are currently under way and going well. I am in the process of creating two new offerings for summer, scrapbooking and music. As these programs get finalized I will let you know.

#### SAILING PROGRAM

From last meeting: Prior to any of you becoming members of this Board Harbormaster, Warner Hazel "loaned" me his Whaler. At that time the outboard was tired however with the help of Fairwind Outboard we have been able to keep it running for most of the time during the summers. This year they (Fairwind) has notified me that it is probably time to purchase a new one. The Corinthian Fleet will not be able to donate this amount of money. It will have to come out of the Revolving Fund. I am currently working on a price for replacement.

The price of a new engine is \$8,500.00. This is a very good price and although the engine will be smaller than what we currently have it will be large enough to provide a safe environment.

#### STRAMSKI HOUSE

I have received two calls from local architects as a result of the article in the Reporter. Walter Jacob Architects returned my call and I have met with Walter Jacob at the home to perform a walk through. Each year his company likes to give back to the community and this year he has decided that this would make a terrific choice. He is an avid boater and loves Gerry Playground as well as the ideas for the house. Although he loves the park as it is, quiet and somewhat private, he is excited about the pier project. I would like to invite him to our next meeting to introduce him to you.

#### Recreation Commission Meeting April 26, 2011 Superintendent's Report

#### Crocker Park

Bathroos: The bathroom project is moving along smoothly and the rough electrical and plumbing are in. The contractor hopes to have the plumbing inspected by the end of the week and the new floor and walkway poured early next week.

Pier Head: I have a punch-list of items that need to be addressed before the project can be complete and have been working with the contractor on getting those completed. I have walked the site with the Building Inspector and he is pleased with the project.

#### T-Ball

The T-ball program got off to a great start on April 9 and we received some very positive comments. The program was rained out this past weekend and we will try to make it up at the end. The program has 65 participants which make up 6 teams and they will play at either 9:00 or 10:00 a.m. on Saturdays.

#### Gatchells

PV Barone Construction has completed the work inside the gate at Gatchells and the area has weathered the rain very nicely. A new guardrail type fence and gate were installed at the end of the parking lot and we received donations from Youth Football and Baseball to help defray the costs. I have sent a thank you letter for the volunteer work they performed.

After meeting with the Fire Chief the area at the end of Everett Paine, in front of the Hamond Nature Center, will be lined as a Fire Lane. The area is marked No Parking but the designation as a Fire Lane will allow the Police to ticket and tow cars. The Highway Dept. is waiting for dryer weather and is planning to line the area next week.

#### Seaside Park

Grandstand: On Thursday, April 14 I was called by the police to the grandstand after a local graffiti artist used it for his canvas. The youth was caught and will be charged. I have been asked by the police to prepare an estimate to be used for restitution when it gets to the courts.







#### NARRATIVE FOR 04 SERGEANT SEAN SWEENEY

Report by Sgt. Sweeney

On the above date at approximately 1400 I happened to be pulling into the lot of Chandler Hovey Park. I observed car in the lot so I pulled in next to it. I have been made aware of the fact that over an extended period of time.

I looked out in the park to see if I could see . I immediatly observed next to a small tree just behind the rest rooms. I could see that was doing something to the bottom section of the tree. I grabbed my binoculars and looked at what was doing. I could see that had a what appeared to be a strip of bark in his hand. then dropped the bark and walked away from the tree.

I immediatly went to the tree that I observed at. I observed a strip of bark approximately 18 inches in length laying on the ground. I also observed where the bark had come off the tree.

I walked over to who was nearby. I identified myself and asked him why he was pulling bark off of the tree. replied "It's dead you can't pull bark off of a live tree". I then told that the tree was town property and he was not allowed to damage it. I then informed that I was aware of the fact that he has damaged shrubbery in the park in the past. at first denied it but then after I informed him that I watched him do it he told me that it was weeds that he was pulling out. then wanted to show me and pointed to some vines growing out of the rocks in front of us. was pointing to the same ones I observed being damaged on the previous incident.

I told that if he were to persist in damaging any shrubbery or trees in the park he would be prosecuted. said that he understood and would not touch anything in the future.

No charges to be filed at this time.
