 - a) <u>Hut at Beach:</u> There is plenty of space and the trailer can remain. Will need to set up a night in September to review property and talk with Dave.
 - b) Glover: Watering has soften up the ground enough that Greg Snow will be able to aerate front of property.
 - c) <u>Plants & Pleasantries:</u> Need prices for 1) removal of evasive plants at Hopkins and 2) work in the butterfly garden at Nature Center.
 - d) Turf Maintenance Proposal: Reviewed document from Sprint Turf for consideration.
 - e) <u>"Tinkergarten":</u> Group looking to use Stramski Property for classes. Wants to make a donation to department for the use of the property. Doesn't want to work with Department to do a co-op program along the normal 75/25 split for vendor. Board feels it won't work; Tim will inform them of the decision.
