Recreation and Parks Meeting Minutes 07/09/14

- 1) Call to order: Chip called the meeting to order at 7:00 PM.
- 2) Attendance:
 - a) Present (constituting a quorum): Chip, Linda, Jerry, and Derek.
 - b) Absent: None.
- 3) Minutes of last meeting: Motion made and seconded to approve the minutes of the 07/01/14 meeting; all in favor.
- 4) <u>Appearance:</u> Leah Goodman East Coast SUP appeared to discuss contract at Riverhead Beach. Discussion included: 75/25 split; rental fees; definition of programs; certified lifeguards on duty; and CORI checks. After discussion:
 - a) Motion made and seconded that the Department exercises the right to extend the 2013 contract to include 2014; all in favor.
- b) **Motion** made and seconded that East Coast SUP will provide a list of all programs with the name of the program, date, cost, and target audience; they will maintain books, collect registrations, and have all checks made payable to the Town of Marblehead; and they must remove the current "Flannery" truck and replace with a container; all in favor.
- 5) Superintendent Search: Motion made and seconded to offer the position to Tim Short; all in favor.
- Timekeeping: Meeting Adjourned: 9:00 PM. Next meeting to be determined.
