GREEN MARBLEHEAD COMMITTEE. Net Zero Roadmap. Thatcher W. Kezer III, Town Administrator, introduced the presentation. The Green Marblehead Committee was formed by the Select Bord in 2020 to focus on creating an energy baseline for initiatives and efforts to lower the carbon footprint of Marblehead. The Committee has focused on developing a Net Zero Roadmap, an action plan to help guide the community forward. The Committee has been working closely with Metropolitan Area Planning Council (MAPC). Brooks Winner, Senior Clean Energy Specialist, MAPC, has been working closely with the Town on this initiative and assisting in developing the plan. Once the draft plan has been presented to the Board tonight and a public session is held on February 15, 2023, a final draft will be submitted. Brooks Winner continued with a PowerPoint presentation to the Board. The Board commented and asked questions after the presentation. The draft Net Zero Road Map can be found on the town's website at www.marblehead.org, Green Marblehead Committee.

FRANKLIN STREET FIREHOUSE. Treatment and Assessment Report.

Presentation. Ryan Foster and Erik Christensen, Foster Architecture, Rebecca Cutting, Town Planner and Chief Gilliland appeared before the Board to present a Condition Assessment and Treatment Report of the Franklin Street Firehouse, which was funded through a grant from the Massachusetts Historical Commission. This project could be funded through town meeting and a debt exclusion override, grants, fundraising or a combination. The Town Planner stated that the Town would pursue all grant options and there may be some individuals who will assist with fundraising options. The report can be viewed on www.marblehead.org.
